## Preface (6<sup>th</sup> Edition)

---

As with all endeavors, the first draft is incomplete and filled with various errors that bother, but cannot be helped except upon a brutal revision. Such was the state of this book project that started in the summer of 2020 as part of an updated foreword to a book published in late 2019. Now, four years on, the clarity of time allows for a more permanent view to put to paper of events lived, and *still to come*.

We entered the 2020s unaware of the agenda that has now unfolded. There were mature conspiracies about long-term subversion of the human will and nation-states. Such high-order plans lurked in prior generations, going back at least 140 years with Cecil Rhodes driving the international desires of others in his orbit. To maintain the power of the British Empire, with too few people, and too many challengers, emanating from the vast Russian Empire to its east and the United States behemoth to its west. Rhodes died too soon to achieve his dream (passing in 1902); but that has not stopped others, well-aligned, from continuing their ambitions where world order nomenclature is not as important as the result: total human control.

A decade after Rhodes's death, Europe headed into its first World War. Alliances were ginned up towards a new war method; financed and utilized to reshape maps inside and outside of the European conflict zone. The Russian Empire fell prey to an internal revolution, though infiltrated from abroad (Trotsky), ending czarist Russia. Germany was handed its defeat. And the Brits formulated their 'special bond' with the US (through intelligence<sup>1</sup>) that work well for the next thirty years.

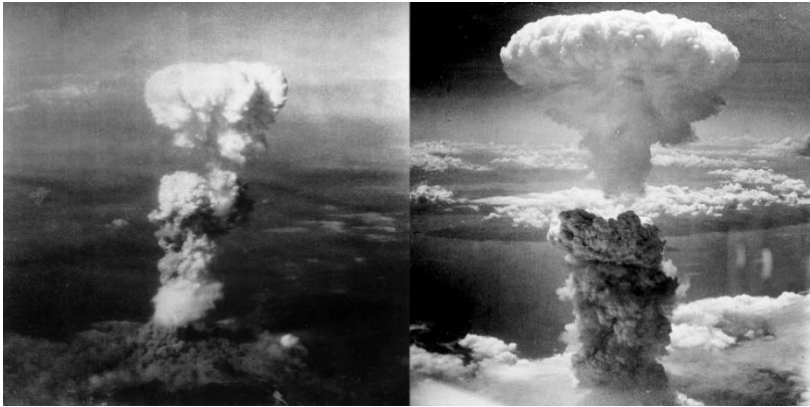
At the heart of present-day initiatives lay the United States of America. Since 1913, the power of the US matured, climaxed, and now has receded with growing illiberal tides. The ultimate expression of that power is seen as that of a U.S. President: an embodiment of that same trajectory, and now, as subverted as the czar of Russia was at his demise.

Wilson's faulty and deep-in-a-winter's-night allowance of the Federal Reserve and the approval of personal taxation, that the Founders deplored and revolted over, onward to FDR's expansion of government agencies, crowding out capital, siphoning off more wealth from the lower classes came through elite lawyers, lobbyists and owned politicians that increased their power too. These groups used a new and now ubiquitous method of information and propaganda dissemination: mass media.

Those two presidents irresponsibly drove the United States eagerly into two World Wars - both under poor and false pretexts - but served the British Empire's designs and desires. (World War II entry was morally justified even with FDR's likely foreknowledge.<sup>2,3,4</sup>) A British Empire guiding hand

guised well - as loquacious leaders like Churchill noted the existence of a “high cabal”; while others dismissed that notion as “conspiracy talk.”

Such conspiracies have explosive consequences when people view them fully and viscerally raw. Truman’s unique place in world history was made by killing instantaneously nearly a 100,000 people *twice* with *two* bombs. Just months prior, General Eisenhower entered the German concentration camp system in April 1945 - at Buchenwald<sup>5</sup> - and was made aware of others, from Auschwitz to Sachsenhausen. Places and names too numerous, and yet too few, when considered against the millions murdered ruthlessly inside of Hitler’s *Final Solution*. Rumor and conspiracy circulated regarding the camps - a gradually escalating place of heinous experimentation, logging of vicious outcomes, and then: hyper-efficiency in mass killing.

Later, President Eisenhower discovered a conspiracy rooted itself deep inside his administration: the military industrial complex. After all his efforts, Eisenhower felt victimized by the early incarnation of the National Security State. JFK, personal foibles aside, made the fatal mistake of crossing that complex, threatening its existence, resulting in his own demise, and if one is brutal in assessment: not by the *lone gunman theory*.

Thereafter, the United States, as economically and militarily powerful as it became, is no longer a Constitutional Republic populated with a vibrant people that understand sacrifice and its unique place held in world history. Instead, that freedom and beauty has been subverted with a toxic and terminally-ill social ideology, corrupted souls across the breath of its government entities, and obsessive warmongering abroad to its moral debasement. And most common people do not know how deep this rot goes. The mass media has militarized its efforts - via control by the intel apparatus (CIA, NSA, FBI, DHS, NED, NIAID, DARPA) - creating labels, smears, deflections, and weapons of mass destruction that don't necessarily go boom, but do destroy men and women that get in its way.

With the entry of Donald Trump into the White House, a milestone in the 'globalist project management' towards one world governance was accelerated to its 2030 terminal. To achieve the long-sought goal of total human control under the present guise of climate emergency and health scares, one needed crises. Crises that were the ubiquitous calling card of the CIA (with MI6): the color revolution to topple governments unfriendly to corporate interests (MNCs) and U.S. State Department greedy desires.

This is not just a United States hobby; other countries, their ruling parties, engage in such actions through influence operations, spying, stealing technology, creating havoc, all backstopped by bankers. Imperialistic dreams never subside when one looks into the networks of actors, the messaging provided, and the battles had at many operating levels inside The Worldwide BLOB™ (Behemoth Living Organization of Bureaucracy).<sup>6</sup>

Robert Kagan<sup>7</sup>, former George Schultz speechwriter, author, and husband of notorious B.L.O.B. operator Victoria Nuland, posted on October 27, 2020 at *Brookings*: "Respect the Blob. Learn from the Blob. Love the Blob."<sup>8</sup> Kagan, a virulent Trump hater wrote a 6,000-word piece in November 2023, hallmarked by projection and intimation that the BLOB (but Republicans, preferably) must get rid of Trump through any means at hand:

"Trump's power comes from his following, not from the institutions of American government, and his devoted voters love him precisely because he crosses lines and ignores the old boundaries..."

Indicting Trump for trying to overthrow the government will prove akin to indicting Caesar for crossing the Rubicon, and just as effective. Like

Caesar, Trump wields a clout that transcends the laws and institutions of government, based on the unswerving personal loyalty of his army of followers.”<sup>9</sup>

Notice the referencing of institutions, and we are but *followers*, not *We the People*, to this BLOB-loving and obsessed Kagan. Those “old” boundaries were crossed by the BLOB, long ago - and *We the People*, of a certain mindset, know it was not Trump that caused those issues. His political rhetoric and exposure of the BLOB’s plans infuriated its protectors residing in Washington, D.C., Davos, Switzerland and Beijing, China.

Kagan is keenly aware of the ongoing plan that the Biden administration is executing. Allowing a 10-million-person invasion of the U.S. southern border (not mentioned), destructing U.S. energy policy, rampant inflation, the proxy war with Russia, led in part by his wife (again, not mentioned once). Meanwhile, Kagan mentioned Trump 145 times in his BLOB article. Predicting a Trump “dictatorship”, mentioned 14 times, because: *The World BLOB* is angry and desperate. Not due to Trump’s prior policies, but because his followers will not give in or give up on Trump. And the BLOB refuses any retreat from the WEF *with CCP characteristics* control plan.

This plan was not a secret as even newly-minted Congresswoman Alexandra Ocasio Cortez knew its terminal date: 2030. This explains her statements in 2019 and the roll out of her *Green New Deal* plan. AOC was selected to pre-roll out *The Great Reset* plan based off her looks and acting ability. Just like Greta Thunberg was deployed for such messaging. Gullible populations seeded with narratives and conditioned to accept them uncritically. Legions of youthful followers have grown; bought up by NGOs and billionaires that operate opaquely through world organizations.

Meanwhile, under Trump’s governmentally naïve nose, regarding the deep hatred held in all the agencies and global corporate entities catering to the intel and military silos, a formalized coup (impeachment) over a phone call, regarding Biden, began in the fall of 2019. This was but a useful distraction, allowing for a militarized “virus” operation that COVID-19 soon became. Through the lockdowns, masks, Floyd riots, attacks on freedoms, election night chicanery to the “vaccines” and the hidden roll out of “digitalization of humanity” across the world, the last four years are but a taste of the crises in store for U.S. citizens; and the world at-large.

When I chose the title *Operation Virus: The Delivering of COVID, Chaos and Communism* (to the United States and the World) in 2020, it was compact, but incomplete. The marriage of Communism and Fascism is more complete. The conglomeration of those two ideologies with Neo-Feudalism and Technocracy is closer to the mark. Mathematician James

Lindsay as of late calls this situation further: “Maoism with American characteristics.”<sup>10,11,12</sup>

What can be rightly noted, without those labels becoming the ongoing argument, is that no one in the world with a desire for free will, and some historical understanding about Totalitarian regimes, wants this agenda. The obsessive need to control a person’s work, their property, their movements, their familial relationships, and most of all, their tongue, is the current trajectory being promoted for Humanity. Yet, our “leaders” are marching us headlong into this abyss, as if, *by command*.

This Agenda serves people that do not care one iota about anyone. These parasitic people are persons we see at the World Economic Forum and those that hide well inside the shadow banking and governance entities. Their power message is expressed through media-trained lackeys, top-tier politicians, and across the various sectors of health, technology, banking, agriculture, to other corporate and policy bodies that are populated and liberally cross-pollinated (or membered) to achieve a singular, collective message akin to *The Borg*.<sup>13</sup> (*Star Trek: TNG* series archnemesis.)

Their messaging hides behind problems with climate and humanity using resources too haphazardly. The climate issue has been routinely used as a fear tool, over the past 50 years, and is well-funded by these Globalized Parasites (GP), using activist groups that are brainwashed to carry out the GP’s orders. If people are to be truly concerned about resources squandered, look no further than these financial thieves and their long cons against their populations. Their hustles on electric cars using cobalt and lithium coming from *third world* places<sup>14</sup>, that pollute those countries and debt entrap them, makes a compelling argument for why one should take their words and throw them into the lithium mine of history. The answers to such climate and resource problems do not come from people that routinely fly around the world preaching this climate gospel while spending mountains of cash to be kept in the best hotels with the best cuisines served. Or investment bankers obtaining returns from government subsidized cash flows and naked exploitation of politically-driven, climate-obsessed policy. (Thanks to the lobbyists hired to achieve these returns.)

Much like the Feudal Kings and Lords, the purpose of these fears and crises is not to solve them; rather, it is to exploit them for further enhancement of power and wealth. The common folk are made to fear and told they must do their part, sacrifice to defeat the King’s chosen foes. The People become distracted and confused by the King’s proclamations and the purse strings opening to show the King’s good intentions, but those are just the enticing tricks of the powerful. Give the population big worries and tell them whatever is needed - to defeat the grave enemy (whether it is their next-door neighbor, an unseen virus, climate catastrophe, or an evil dictator, preferably, all the above in the 2020s) - and find the right

people, experts, scientists, educators, and master media manipulators to sell the *Big Lie* worldwide.

The power of media agents (IA) has evolved since Gutenberg first broke the monopoly on information (and its dirty royal cousin: *disinformation*). Through the Renaissance, to the Age of Enlightenment, the people became literate and could, for a price, put their thoughts to paper for the Masses. By the cusp of the American Revolution, up to 90% of the public in the Colonies were able to read. 1776's *Common Sense* was a massive political best seller in the new United States. But as with any medium (and thus, "media"), power-hungry forces congealed to control the print industry, namely, Hearst and Pulitzer.<sup>15</sup> Further along this course of history, these powerful forces (now named Bloomberg, BlackRock, Vanguard or State Street<sup>16</sup>) bought out print, radio, then TV, and finally, social media. The well-financed parasites have hijacked information, employed thousands of government agents and "experts", forming disinformation networks (GEC, CIC), knowing full well what they desire people to know.<sup>17,18</sup> The Worldwide BLOB network was born out of the *World Wide Web*.

One of the 20<sup>th</sup> century masters of print, William L. Shirer, wrote *The Rise and Fall of the Third Reich*. In *The Rise's* foreword, Shirer discussed the breath of time between tumultuous events and writing on them, noting the French viewpoint on enormity of pivotal 19<sup>th</sup> century events:

"[T] his view [is] especially prevalent in France...Nothing more recent than the Napoleonic era, I was told, should be tackled by writers of history.

Most historians have waited fifty years or a hundred, or more, before attempting to write an account of a country, an empire, an era. But was this not principally because it took that long for the pertinent documents to come to light and furnish them with authentic material they needed? And though perspective was gained, was not something lost because the authors necessarily lacked a personal acquaintance with the life and the atmosphere of the times and with the historical figures about which they wrote?"<sup>19</sup>

Shirer noted as well that with the massive trove of documents, the luck of capture of them (in their entirety), it was obvious to him to do what he did: write a masterpiece on this *then* darkest point in humanity's history.

Shirer intentionally noted his method; which one hopes to mimic and approach to some futile duplication: "...in this book I have tried to be severely objective, letting the facts speak for themselves and noting the source for each. No incidents, scenes or quotations stem from a wild imagination; all are based on documents, the testimony of eyewitnesses or my own personal observation."<sup>20</sup>

When speculation is engaged in, he (and I) will note that. One's interpretations, yet again, are not without an avenue for dispute. And to quote Shirer, yet again, one comes at this work with "what knowledge and experience I have had." And it may take many more years and "drops" of information to provide the deeper breath and scope of the lies, cons, and corruptions. Some revelations skip scores of time; or die with the actor(s).

As for intelligent speculation, it is one's contention that the current set of events is even more Earth-shaking and pronounced in its reach than World War II was. While the "defeat" of Nazism was commendable and absolutely necessary, this achievement was not all-encompassing. The smoldering embers of that false Reich landed later in the United States.<sup>21</sup> Eugenics never went away either; rather, this racial-mental philosophy hid behind "rights" movements, healthcare, and legal precedents (Roe v. Wade).

The more pertinent *achievement* of World War II was the development of world bodies that desire *even greater control* than their 20<sup>th</sup> century hyper-nationalistic counterparts. That nationalism was driven by a force, often, a cult of personality, and political ideologies birthed in the century prior, Communism and Fascism, and wielded by the likes of Hitler, Stalin, Mao, Tōjō, Mussolini, and Franco. Not to ignore attempts in France and United States to adopt socialistic-driven ideas, or the absence of certain countries' major involvement in WWII, that are specifically important to the present agenda: Brazil, Australia, Saudi Arabia and India.

The world today has decidedly inferior, personality-lacking leaders - Von der Leyen, Sunak, Macron, Scholz, Trudeau, Albanese, Lula, Modi, Putin, Jinping, Biden - but these figureheads co-conspire with deeper benches of would-be billionaire autocrats (with their own plethora of technocratic minions); and with larger non-governmental entities and those global bodies (UN, WEF, WHO, BIS and rising organizations with world-dominating ambitions (BRICS+)) collaborating visibly and subverting the nation-states of these dull (and demented) would-be dictators. The nation-state is to be subsumed into a global village through whatever means gets the most *compliance* from the people the *quickest*. An ongoing mission still incomplete as of this writing in March 2024.

The global reach of this burgeoning, international-flavored 4<sup>th</sup> Reich, this time, is not done through force of military *per se*; rather it is done through military-grade mass media propaganda, economic warfare, Agency-NGO warfare outfits and governments pointing their fingers *inward at their populations* instead of *outward* at the usual totalitarian's enemy of choice: other populations or their leaderships. The globalist hands of the present learned well from prior iterations of these total control plans. The political forces gladly outsource their policemen to other localities (so as to squelch resistance) through brazen brutality because there is zero connection or allegiance to the local populations. This was exemplified in Canada when

highly masked up forces showed up to handle the Trucker Convoy. Police are useful, “following orders” idiots for their paychecks, willingly attacking their superiors identified group of choice; and some police enjoy violence on the random stranger (and are recruited specifically for that reason).

The Globalized World Order Parasites (GP) learned lessons well from the two World Wars and the intervening proxy wars, providing opportunities to improve warfare tactics and apply them to civilians. Now, with cellphone tracking, NSA data collection, algorithms and Artificial Intelligence (AI) that is programmed for this purpose, military-guided activities are based on boiling-of-the-frogs’ responses to the stimuluses provided for various pots of people. Those frogs are us: the common population.

Add-in divide-n-rule and invisible enemies to this slow boil mechanism, the demoralizing and destabilizing of Western nations, the main goal, and throw in urged mass migration/invasion, forced energy reduction, consumer restrictions, and social engineering at a level never seen across all of humanity, and this far exceeds the plans of the 3<sup>rd</sup> iteration of a Reich. Ultimately as well: substantial population reduction is a couched goal and its mechanisms for success are already bearing fruit.

This is a 5<sup>th</sup> generation unrestricted warfare, and its itinerant and evolving features are being perfected through learning how people respond to its application.<sup>22</sup> While people continue to believe this overall plan is but a “wild conspiracy” or note how the GP pull back when farmers protest, or marches/rallies pause their destructive agendas, this is a psychological and spiritual war, unceasing until their ends are achieved. It is a war on humanity that is on 24-7. Any actual defeats to the GP will be met with counteroffensives. The GP’s unseen actions in finance, technology and science - fields dominated by the rich and powerful - will get their experts to do even greater harms if need be. (Their information agents, like a 21<sup>st</sup> Century Tokyo Rose, will gladly get the population overconfident they are making a difference, while they are actually losing ground.)

**World War II echoes:** a German-born and speaking guy has bragged about penetrating the cabinets of governments. Klaus Schwab was born in 1938 into the heart of the penetrating actions that was the rising totalitarian 3<sup>rd</sup> Reich. Schwab’s father, Eugene Wilhelm, was highly connected to the Nazis, if only due to his managing a highly respected, Nazi-lauded machining operation on the border of “neutral country”: Switzerland.<sup>23</sup>

One of his penetrated cabinet members, finance minister Chrystia Freeland has her Nazi family past. Her boss, Justin Trudeau, has a family history intersecting with Fidel Castro. A marriage of Fascism and Communist ideas in Canada? But back to our cult-like character.



Klaus is not the clear, *final boss*. Much akin to Adolf Hitler, who was well supported by major industrial titans, it is, as always, about the *financiers*. The bag of debt hanging over the Western World has the moneyed folks seeking a Ponzi way out through a dominating digital world currency. Take digital identity and money (CBDC) and tie it to 24-7 surveillance of health, movement and social media and fuel a new Ponzi-Madoff-Fried Scheme off genetics cum AI/Transhumanism investments. Globalist Parasites reimagine a world with *all The Rights of Man* under a global scoring system. Their scoring system managed by AI (Google's Gemini?) with a programmed driven pathos<sup>24</sup>, or a narcissist's whimsical keystroke, may sit half-a-world away grinning at humanity's freedoms eroding to their ultimate demise.

This explains the eager cooperation with the decade-long prototyping by the Chinese Communist Party (CCP). The virtual prison yard of social control on a billion plus that American tech companies Google and Microsoft gladly assisted along in the 2010s.<sup>25</sup> Bill Gates, a friendly Sinophile and Klaus chum, captured the WHO's agenda with heavy financing, picked off agricultural interests, tested vaccines on huge populations in Africa, India, and through his friends in the NIH (formerly Dr. Fauci) and most Western countries as well. Gates bragged about vaccines' return on investment. And Gates is not the only braggart among the GP crowd; just the most visibly socially unaware of the lot.

Behind Klaus Schwab lay royal ties - King Charles III - that have always had their designs to maintenance great financial power despite the egregious losses of the mighty British Empire, starting with the 1776 American Revolution. Others landing in this financial hopper (Rothschilds)<sup>26</sup> are tied to the central banks around the world. Those that control the printing of fiat money<sup>27</sup> and can routinely make decisions that no one ever voted on, should be a final indicator of *who runs us frogs* and why these souls are never *very visible, when it matters, and never answerable for their decisions (because it always matters)*. (Central Banks with opaque ownerships and sinister designs; unless one thinks 100% control is a good thing in the hands of people barely known, like: Augustin Carstens.<sup>28</sup>)

Lastly, this work could not be achieved without the 100s and now 1000s of independent common people that have noticed keenly this labeled (and re-branded, again and again) 2030/49 World Agenda. These people faced smears, were called conspiracy theorists, for pointing to the documents of the GP. They faced the 5<sup>th</sup> gen warfare from *The Worldwide BLOB*: all the apparatuses of governments (intel, defense), NGOs, guild organizations, and the most favorite arm: the 4<sup>th</sup> Estate, *the Billionaire Globalist Media*.

More exasperating, a substantial part of the common population chose to bury their heads in the sand and ignore published reports and overt and

well-timed media appearances to pitch either: *Build Back Better* or *The Great Reset*. Such propaganda has a particular rhythm and phraseology for the Masses to swallow. This too echoes the 3<sup>rd</sup> Reich and Stalin's USSR. (Again, the totalitarian marriage is not by any accident.)

Luckily, those 1000s in the quest to inform and educate on these sinister plans have been resilient and peaceful, despite threats and cancelling of their social existence for speaking out. As always, one side is held to a perfection standard. And by side, one contends, the side speaking truth, facts, and warning of the agendas to come, not the amorphous political party we are encouraged gleefully to join for divide-n-rule purposes.

This while the GP media, a most craven group of liars, cons, and criminals in their complete dereliction of "journalism" will be the ones, like Goebbels taught well, to judge anyone that commit "thought and speech crimes" as dangerous to "democracy." When such media operates at the sole behest of State Power, and given how many former U.S. spokesmen and women from intel to the White House rotated easily to ABC, NBC, CBS, CNN, FOX, MSNBC, one should be highly alarmed. When the State creates disinformation boards, funds NGOs and Universities to do tasks to circumvent the Bill of Rights, both the State and those that operating on itself behalf, have committed crimes against the entire population.<sup>29,30</sup> (The PATRIOT Act opened the door broadly for such abuses and nothing was done about it. This has metastasized, as Julian Assange noted, and now, efforts towards the RESTRICT Act are being teed up.<sup>31</sup> But the methods of the Worldwide BLOB are always ongoing.)

This counter-movement hopes to awaken the *Mass Formed* to the nature of the militarized COVID, social and economic propaganda used expertly against them. But this counter-information work is still not fully finished; nor is it easily done without enormous sacrifices.

The time is running very short to stop and roll back this agenda worldwide.

Since I began work on this project, in late spring 2020, one has worked temporary warehouse jobs for *BlackRock* companies (Amazon, UPS), tutored, and worked late shifts at a convenience store. One set aside their hopes of going back to a 'new normal' of being a very mediocre industrial engineer with background issues.<sup>32,33</sup> I went from a good 'credit' score to default judgments on credit cards from the big banks (Bank of America, Citigroup, et. al) to get through the morass that was the agenda tied to SARS-COV-2. One will contend this decision was a worthwhile sacrifice.

For in the long run, we all die without a penny to take with us, and debts are merely the slave tool of the usury class foisted upon all Humanity. When governments bear no responsibility for their recklessness with the purse, how does one deem it worth the trouble to adhere to contracts?

*Force Majeure* took place in March 2020 across the Western World.<sup>34</sup> Everything since was a conman's dream. And trillions were printed and tossed on the bonfire consuming your inalienable rights with little ado. That was but one visible pillar of the One World Agenda.

One also hopes an axiom can be born from this: the measure of the journalist is inversely proportional to their wealth and weekly paycheck from 3-5 letter media outlets with plutocratic billionaires in charge. It is what one does without any assured reward, that challenges the GP: the powerful and corrupt, that sees people, *presently*, as just bits of error-filled DNA to be exploited for the next market to monopolize.<sup>35</sup> This separates the real journalist from the well-fed, seven-figure frauds. This said, knowing what to glean, information-wise from those powerful propagandists, now falls under the *Art of Gathering Intelligence*.<sup>36</sup>

Along the way as well, I discovered friends in the search for answers. Some were *for a reason*; others *for a season*; and hopefully, some are for the remainder of my time on this planet. Some hold PhDs; others are politically-connected; others still are just the common man or woman trying to do a 9-5, or 11-7, while holding their families together.

*Hold their families.* That ultimately has to be the goal of anyone with morality and understanding of what is at stake and stops listening (or obeying) *the media of the monsters* that did this for their own "reasons."

What those reasons are depends on the individual and proximity to the nexus of a host of characters. Nonetheless, they do have *their reasons*. They will tell us this with a practiced concerned look, a subtle flash of baleful eyes, and the psychopathic duper's delight, and a lie about how this was for, "one's own good."

As Margaret Anna Alice of Substack wrote, poetically, and truthfully:

"You know in your heart what is true, and you speak it.  
And no one can ever shut you up again.  
Even if they kill you.  
Your bravery will outlive you."<sup>37</sup>

This 6<sup>th</sup> edition is a major revamp of all prior publications. In the most pertinent cases, I have used Archive.org or Archive.ph to save sources (if citing verbatim a quote from an article) because we live in extraordinary times. For any link included in the endnotes, one has saved the source document (archive.org for PDFs and archive.ph for html documents).

The citations will point to a reliable source when not discussed explicitly in the main body. Videos cited reference back to one's *Rumble* channel in the

hopes that platform stays alive and stable. In many cases, the video is a mirror of YouTube or a Twitter upload. However, both platforms are or can be easily corrupted. *It should be readily apparent that a cited source can be memory-holed faster than one can replace it.* That has done great harm. By deleting content and a creators' work from a platform, we lose the ability to perceive the message and evaluate it accordingly. I have been a victim of those policies - my podcasts. (Now relocated to *Substack*.)

There is an extreme desire through national and international bodies to control all information on the planet. Deciding who has an approved voice to speak and who shall be demoted, and therefore, silenced. *The Worldwide BLOB* is very busy designing networks (GEC, CCDH, SIO, CIC) and linking them back to intel-driven agencies (DoD, CISA, DHS, NSA, CIA, FBI, et.al.) But the end is obvious: silence and discredit anyone that dare speak or write against their preferred narratives a.k.a. lies/disinformation.

More revelations come out daily regarding the deep origin story of these unconstitutional pushes from inside the U.S. government (alongside the European Union). Julian Assange trip-wired into secret communiques that our governments do not like you knowing; and he published them. ## One World Order

---

*“We know where we want to end up: success. We want to matter. Wealth and recognition and reputation are nice too. We want it all...This is the thinking that creates the Faustian bargain that turns most clean ambition into shameless addiction...because no one ever said, reflecting on the whole of someone’s life, ‘Man, the monstrous ego was worth it.’” – Ego Is the Enemy, Ryan Holiday*

*The Great Reset* is about the controlled collapse of the post-World War II monetary, political and social systems and their replacement with techno-Totalitarian systems, with similarities but for their geographic operating centers, and from which they will be no conceivable escape by the population.<sup>41</sup> This is to be “operational” by 2030. The monetary aspects of the prior Bretton Woods-based World Order are cracking from enormous debt and ongoing currency devaluation. Those debts are rising above \$325 trillion, with credit derivatives well surpassing \$700 trillion (notional)<sup>42</sup>, and long-term statutory liabilities incalculable across all 194 UN-WHO acknowledged countries, but hazarded these are on the order of: one half-quadrillion dollars (\$500 trillion).<sup>43,44,45</sup>

The first political fractures - the cold war ending - arose happily in 1989, as *The Berlin Wall* fell. *The Great Game*<sup>46</sup> 2.0 launched, thereafter, but with a new wrinkle: China rising off the backs of Americans too busy to notice,

too propagandized to admonish their corrupted political class, and too distracted by technology, from the internet to iPhones. Geopolitical concerns took a backburner to searching *Google* and *Grindr*.

The social realities are the most jarring, if one believed in meritocracy, minimizing internal strife, and operating from *actual* classic Western moorings tied to a God, a family, fair treatment and respect of people and their traditions laid out since the Magna Carta and through to the U.S. Constitution.<sup>47</sup> The hypocrisy class, that is Washington, D.C., has made foreign wars its overarching, lucrative agenda, not at all concerned about how other cultures see their military campaigns. Goaded on by our British cousins' antipathies towards Russia, while preaching about "protecting democracy" and a "rules-based international order,"<sup>48</sup> came with a pricey domestic bargain for all. The destruction of a vital, democratic republic and violating "rules" and civil rights without any consequences, while showing deep abiding contempt for their citizenry. This contempt spans all the Western Democracies, growing for many years, but presented most vividly with the arrival of COVID-19 at the Ides of March, 2020.

Such hard-won traditions are destined for death.<sup>49</sup> The financially failing promises of plenty, prosperity, and pensions that were made by these agenda operators, they cannot honor; nor will they attempt to.<sup>50</sup> This as the *next* World Order forms quickly before our eyes, centered on China.

There are many faces to this latest iteration of a one world order, thousands actually, that have been trained, mentally-conditioned, and even "bred" to rule over the Masses. They see Humanity as the Ancients did: pliable and useful slaves that must be completely controlled; or extinguished from existence if they dare ever to rise up against *The Elite*.

~

The birthing of such a grand agenda rarely begins at a glitzy conference room or a Swiss Alps retreat for all the world to see. Rather, it begins at a home, or in a factory, or a bar, or even through a graduate course taught by an awe-inspiring lecturer that produces that final trigger of inspiration. The student soaks in all the personal thoughts of his university mentor, his Plato, that goes along with a host of preconceived notions and prior upbringing that has excited the mind to think of global possibilities: that with just the right amount of effort, manipulation, and congealing of acolytes into an organization to carry out the deep penetrating task of the invisible hands, that ultimately *finance* this collective control aspiration, that no one person can ever stop - not even a U.S. President.

This might be an apt description of what Klaus Schwab became after attending the lectures of his mentor, Henry Kissinger, at Harvard in 1967.<sup>51</sup> Schwab's growth thereafter from a German-born professional engineer to the leader of the *European Management Forum* might also be seen as a

substantial lifetime achievement in 1971.<sup>52</sup> But for Klaus, that saw his mentor rise to U.S. Secretary of State in the Nixon administration and go secretly to China in July 1971<sup>53</sup> just months after ping-pong diplomacy<sup>54,55</sup>, a desire to *exceed the master* grew, happily, it appears.

With Kissinger's Chinese trek, the mission was to sway Mao permanently away from the orbit of USSR *with democratizing and globalizing Capitalism*. This occurred as Mao's Red Guards torn down "the four olds" during the Cultural Revolution of the late 1960s. After Nixon, this policy was fully initiated with new leadership in the United States and China.

Schwab's own ambitions must have been stoked higher from the observance of his personal Plato's ascension into the pantheon of geopolitical masters. Throughout the 1970s, Schwab's relationships with European powerbrokers grew, and soon followed Kissinger's groundwork to China's main doorstep. Seamus Bruner wrote in *The Controligarchs: Exposing the Billionaire Class, Their Secret Deals, and the Globalist Plot to Dominate Your Life* how quick Klaus was to seek a Chinese audience:

"In 1979, Schwab traveled to Beijing to personally invite the new leader of the Chinese Communist Party (CCP), Deng Xiaoping (whom Schwab had been following 'with great interest'), to speak at an early symposium in Davos. And soon after, twenty European CEOs followed WEF to China to develop the fledgling economy. While Deng declined to attend WEF personally, he sent a delegation of his economic reformers, which signaled to Schwab that the new CCP ruler was open to doing business (pg. 77)."<sup>56</sup>

The intervening years since China opened to the West (with zero "democratic" changes) shows Klaus inviting Kissinger to his *World Economic Forum* (WEF)<sup>57</sup> and recounting his origin story starting from his Harvard course with Kissinger. Likewise, with each new Paramount Leader of The People's Republic of China, Schwab invited them to deliver the keynote WEF address. WEF runs a "Summer Davos" in China since 2007 (pg. 78).<sup>58</sup>

As a student of history and engineering, Klaus more than knew about the potentiality of rising from relative obscurity to the leadership of an energetic group of like-minded people. Klaus's birth in Ravensburg, Germany was just fifteen years after Adolf Hitler's *Beer Hall Putsch*; and like Hitler, Klaus's origin story included less German, with more Swiss and Austrian touches, but never let a confusing starting point deter from one's deeply-ingrained desires. For Hitler, it was fanatical nationalistic reunification of Germany and Austria (sans the ethnic populace) and revenge against Jews and others Hitler deemed unworthy; for Klaus, it is fanatical global public-private partnerships, definitional Fascism, at a scale hitherto unachieved; and humanity's transitioning, after its downsizing through a war-like, Maoist identity politics attrition, towards a Klausian

dream of *Transhumanism*.<sup>59</sup> Klaus's World Economic Forum promoted, slickly, *no property ownership*: an absolute Communist tenet.<sup>60</sup>

Unlike Hitler, Klaus learned violent pushes, the crude, 'old types' of war, are little tolerated in a hypermedia environment, as he experienced in the 1970s. Rather, Klaus deploys propaganda through media, more properly, to acquire corporate allyship. Growing up in Cold War Europe, radicalism was heavily highlighted in mass media whenever it included any of the thuggish Nazi tenets or deeds. Klaus, and his *World Economic Forum*, instead worked on talent development in the media, the art of presentation, grand narrative building, and the opportunistic catastrophizing of any *global issue* to a workable end for power attainment. In a retrospective published on the WEF website, this early foreboding of climatic doom, was highlighted:

"1973 - A prescient warning on the environment

Two developments distinguished the third Davos meeting. First, Aurelio Peccei, the Italian industrialist, delivered a speech on his book 'The Limits to Growth', which had caused a sensation by calling into question the sustainability of global economic growth. The author outlined the choices that society had to make to reconcile economic development and environmental constraints."<sup>63</sup> [My emphasis.]

The reconcilable end - garnering fascist control through his forum - came through subtle, hybrid warfare-like techniques.<sup>64</sup> Or as mathematician James Lindsay pointed well to, "a middle-level violence," that make it difficult to respond to without losing one's "moral authority."<sup>65</sup> By posing all humanity-level issues as an impending crisis, with an identified victim class (whether manufactured or marginally existent), that must be satiated via equity measures and without debate on the logic or constraints therein, the WEF corporations that Klaus has corralled can impose restraints or implement policies that governments cannot do directly, or lawfully. Through emotional arguments to pull at the heart strings of those who live in their emotions, and define themselves as "marginalized" or "otherized"

irrespective of their relative well-being (in the Western world), these corporations can specifically cater to their captured market: a victim class.

Then, these corporations are backstopped by banks and governments to pit the masses against each other while other mechanisms are put in place. This is the ESG program of environment, social and governance, that is tied to DEI: diversity, equity and inclusion. Instead of responding *apolitically* to all their potential customers, global corporate decisions are based off a supra-international confab operating nebulously with government officials and world organizations to fulfill *Agenda 2030*.

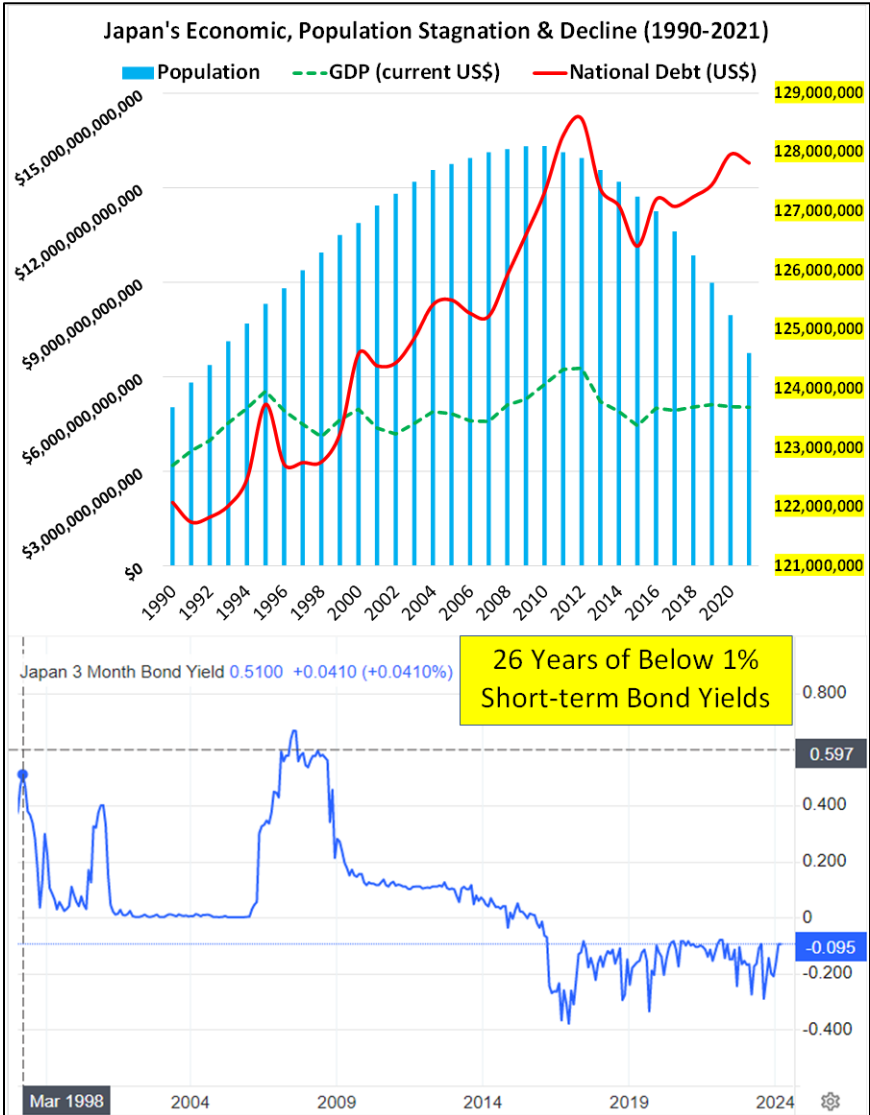
Instead of excited rhetoric that blamed Jews for all of the Germany's ills, or persuasive propaganda that spoke of "the greater good" Adolf could, or would achieve, *with expansive totalitarian powers*, Klaus talks in *grand narratives* about a transhumanistic and a fully equitable world if given the proper collaborations between multinational corporations (MNC) and well-aligned institutions nested deeply inside of nation-state governments. These, Klaus might intone, can achieve more than any leader *of any nation ever will*. With the financial crisis of 2008, a critical juncture was hit across an array of deployable technological fronts to achieve greater control through crafting a reality to the Globalized Parasites (GP) liking.

Communication capture and big data became a favorite tool of the globalized partnerships to gather, sell, and later, exploit for algorithmic testing and control methodologies. The ubiquitous spread of communications with the DARPA-intel backed social media provided more insights, given freely, into the masses' thinking about all topics, but most importantly: their growing disdain for those that economically and politically rule over them. This disdain was not to be rectified by better policies; instead, it was to be used against them along classic divide-n-rule, hidden enemy, and fear-based (or trauma-based) control techniques.

Genetic science provided key tools as well. With the human genome unlocked by 2002, virus/pathogens adaptable in the laboratory settings, gene editing (CRISPR CAS 9) brought online by the mid-2010s, the ability to modify, edit, enhance, and stall human adaptability, permanently, provided an awesome power the GP could not resist; ethics be damned.

With the 2008 fallout of credit and financial issues, an intentional global shift (and allowed technology theft by China) to build up their social

control grid for their docile masses penned in huge cities, meant the Western powers needed to stay out of economic depression that could trigger revolts and revolutions. This required zero-interest rate policy (ZIRP). Such interest rates, seeming to work well in Japan, to keep a population satiated while it stalled (population aging, declining with a stagnant economy for thirty years) into oblivion.<sup>66,67,68</sup> This was formally called Modern Monetary Theory (MMT): national deficits do not matter.<sup>69</sup> When in actuality, debts do matter; and later paid for in blood and deaths.



With the new leader of the West being a mixed-raced socialist of dubious origins, the opportunity to deploy racism, sexism and trans/homophobia

was all the more sought to deflect off the economic failures of the GPs responsibility for financial distresses. With the election of Trump, this too provided a golden opportunity for a massive Overton window shift from Obama's rhetorical takes. As the legacy media was tightly controlled under Obama, these propagandists were let loose to do as a newly defined entity came online to create a hostile, confused, and disinformed public space. In other words: an easier group to control with an "info" apparatus in place.

To do this, a public-private partnership began working openly from the last days of the Obama administration against anyone considered too populist or nationalistic. Most vividly, the backlash against the United Kingdom's Brexit vote on European Union membership and Trump's 2016 election win. These followed the February 2014 Ukrainian CIA-backed Maidan coup and Russian invasion into Crimea. From these events, information warfare became the key battle space for Western powers and WEF members too. As one Obama administration official, Ben Rhodes, labeled it: *The BLOB*.<sup>70</sup>

This BLOB (Behemoth Living Organization of Bureaucracy) was no overnight affair. Rather, such established in the United States under the guise of limited governance, but is effectively a sprawling, unelected politburo of: alphabet agencies, media outlets, tech companies, nonprofits, university campus organizations, international bodies, corporations and banking arrangements populated and tasked up for an overarching technocratic mission of information control across the West. As social media grew, the ability to link in more and more partners, and align them to this control mission of the "unwashed" masses, even those folks they routinely interacted with, became the primary objective. This though did not come about without the U.S. military (NATO) and intelligence (CIA, MI6, Five Eyes) directions and orders. Because of this, nation-state sovereignty is a mere façade to keep the masses duped into thinking their votes matter; when this BLOB and its appendages coordinate to make sure *democracy in a Republic* disappears up into the BLOB's final decision-making authority.

Such sovereignty is to be abolished on a national level by this method. Thus, all flavors of "nationalism" are routinely demonized by the BLOB; the existing culture atomized; and made into a non-descript, multi-cultural horde to be at the whimsies of the richest and most powerful GPs through the BLOB. One's personal thoughts are to be sanitized by information agents (IA) to parrot what the corporate partnerships congealed with the State say, and further controlled by world bodies (via "health and safety" treaties/laws) that the BLOB approved into its one world order orbit.

This international fascism network decides on the approved ideas and permitted thinking amongst the rabble. The COVID-19 "plan-demic" was a worldwide test run for intense coordination and destruction of populism, nationalism and freedom movements of any kind. The BLOB, often called the *Deep State*, has Agenda 2030 to execute for the highest-ranking



members inside the BLOB's vast network that siphons off taxpayer funding for its existence and expansion. [Note: Stop funding BLOB entities.]



The BLOB's main targets are any movement that decentralizes and democratizes information back into the hands of the people writ large or threatens any of its overarching power to control. Thus, the demonizing of "nationalism." Such is not new. Richards J. Heuer, author of the 1999 CIA manual, *Psychology of Intelligence Analysis*, remarked as a side note on nationalism intersecting situational logic paradigm (33):

"The subject of national separatist movements illustrates the point. Nationalism is a centuries-old problem, but most Western industrial democracies have been considered well-integrated national communities. Even so, recent years have seen an increase in pressures from minority ethnic groups seeking independence or autonomy. Why has this phenomenon occurred recently in Scotland, Southern France and Corsica, Quebec, parts of Belgium, and Spain—as well as in less stable Third World countries where it might be expected."<sup>71</sup>

Those examples emanated from a CIA manual. Such a framing works too if one were to justify destabilizing actions against such movements and nation-states that are not considered as operating *advantageously* for the U.S./U.K. governments. Any nation-states that operated outside the

central banking model (Iraq, Libya et. al.) by control of their own nation's wealth and trade policies; made in their local currencies; utilizes their natural resources; and builds infrastructure without external debt strings attached to the U.S. Federal Reserve, the IMF, or World Bank, is a threat.

With conveniently-timed destructive actions, such as forced migration (through hasty evacuation or war), occurs to “flood the zone” of the debt-addled western democracies. Offer to provide all illegal entrants into a country, irrespective of their background, shelter and jobs, *that don't exist*, due to manufacturing gutting over the past thirty years and climate suicide compacts made recently.<sup>72</sup> This depresses wages while the BLOB created inflationary pressures with ZIRP and supply chain disruptions later. This causes intense friction and tension in a national culture, thus killing two birds with one color revolutionary stone. Destroy any national identity desiring independence from oligarchic BLOB banking empire while smothering nationalistic embers through restricting the civil rights of the newly invaded citizenry that protested these self-sabotaging policies.

This has been routinely deployed since the CIA's inception.<sup>73</sup> Relevant recent example: Ukraine in 2014 saw a color revolution that spawned 2022 activities: a US-Russia proxy war.<sup>74</sup> As of this writing, there is an estimated 400,000 Ukrainian dead.<sup>75</sup> Migrants from Ukraine are landing in Ireland, a country of barely 5 million as of 2021. Ireland accepted in over 100,000 Ukrainians and tens of thousands of middle eastern “refugees.”<sup>76</sup> Ireland is run by WEF leaders (Varadkar)<sup>77</sup> who demonize their local populations routinely and want to control their nationalist tongues without any debate. The UK-WEF BLOB appendage is busy achieving Ireland's cultural demise.

The ultimate desire for such *internationalists* is to erase *national* boundaries, their cultures, language, religion, and have no local/provincial authority operating on the behalf of the locals' best interests. A *tableau rasa* of a geographic map - remade at a globalist's whim. The invading migrant warfare tactic assists the building of a single sovereignty in the World, a pyramid structure with the UN-WEF-CCP collaborating, that will reach down to the local populations through its controlled bodies (NGOs, foundations, think tanks, and military). These sorts of entities will (over time) deploy more technocratic tools: AI-controlled drones and 24-7 internet technology (surveillance) linked up to one's money (CBDC). These are still developing, but growing more intrusive, and pernicious, *daily*.

By contrast, one will not see China disintegrating their culture or territorial boundaries to import in millions of *non-Han* to their country (leaving aside food concerns). No BLOB members admonished the Chinese on their coal-fired power plants numbers or held them to any account over CO<sub>2</sub> emissions. Chapter 2 reflects on their “century of humiliation” and how the CCP's revenge plan aligns well with the BLOB/WEF/UN's 2030 Agenda.

Such project planning kicked into high gear at Rio De Janeiro in 1992 for Agenda 21.<sup>78</sup> In one of many UN documents on “climate change”, CO<sub>2</sub> was the agreed upon focus: “[W]ith the aim of returning individually or jointly to their 1990 levels these anthropogenic emissions of carbon dioxide and other greenhouse gases not controlled by the Montreal Protocol (12).”<sup>79</sup>

As time has moved along, from the Kyoto Protocols to Paris Climate Accords, this climate change obsession increased like the monetary price tag to “solve it” also does. With no logical or open planning, on the energy production side, to include nuclear energy into its framework. (Note: since we have such destructive leaderships and governments that see war as a game, and their people as a huntable sport, we are unlikely to apply any rationale for how ubiquitous, cheap and clean energy might lessen world tensions. If such energy security was ever a goal, one doubts it ever is.)

But this has never been about climate change or fixing the world’s problems. Like always, there are people that guise agendas well behind “constructs” to get the lowest common denominator of people to buy in. Through a sales pitch that repeated platitudes about caring and equity, because many want to feel they can contribute to a *utopia* where everyone is equal, and all things are “fair.” The power players - bankers and massive property owners that run politicians that control armies and weapons - say wonderful things in addressing an “existential threat” to get their climate agenda into the zeitgeist. Widely propagated to those too gullible or too incentivized to think too hard about the long-term repercussions of such agendas to Humanity’s liberty and enterprising spirits being extinguished.

Rosa Koire, author of *Behind the Green Mask*, noticed this kickstarted with Rio, the United Nations, and Agenda 21 & 2030, and summarized it thusly:

“It’s a blueprint. It is the action plan to inventory and control: all land, all water, all minerals, all plants, all animals, all construction, all information, all energy, all means of production and all human beings in the world. It is a totally comprehensive plan.”<sup>80</sup> [My emphasis.]

Further, this agenda tied to *communitarianism*. Broadly speaking:

“Communitarianism is the balancing of the individual’s rights against those of the community. In the US Constitution we are guaranteed rights that we were born with: life, liberty, and the pursuit of happiness. The last right, under the philosophy of John Locke, was ‘property.’ Property is not just land. YOU are your own property. The execration of slavery was a fundamental element in the original draft of the Declaration of Independence.

So how can you ‘balance’ individual rights with those of the community? The community has no rights under the US Constitution. Individuals have rights and responsibilities, but the community as a whole---what is that? The collective? Whenever you ‘balance’ or subsume or subordinate or

consensuize the individual's rights you'll get something different from what we are guaranteed under the Constitution."<sup>81</sup> [My emphasis.]

Western Democracies are being *destabilized* to bring forth "not balance" but "imbalance" for this top-down control's implementation. Where one's personal rights are always irrelevant to some nebulous community concept the globalist forces will define, on a whim, and sell their militarized propaganda to the public to garner the public's begrudging acceptance.

In Sean Stone's *New World Order*, the political purpose of this order has been a consistent obsession, going back over a century, but rears its ugly head every time a world crisis is brewed up by forces, controlled and antagonized, to achieve these grand technocratic plans by any means.

"In 1940, the Committee on Europe thus discerned that the movement toward world government must be both 'centripetal and peripheral,' for just as the world government gains centralizing authority, 'regional decentralization will effectually distribute power to the smallest local unit, the city and the village, down to the elemental unit which is the family, while world-wide authority will make cooperation possible among them all.' Their antipathy to national organization emphasized a specific opponent: Germany, the nation which had only recently managed to centralize its industries in order to develop its economy and arms production to a place of asserting itself once more as an imperial power; 'all centralizing structures - and not Germany alone ... must fall into smaller federal units.'

The Committee on Europe was fundamentally declaring war on the nation-state, to balkanize it into a 'deflated and disciplined,' and thus manageable proportion of local groups and organizations, 'under the law of the world-state' for the so-called 'peace' of tomorrow. Likewise, the Round Table delegates had discussed the implications of a future world order in a League of Nations structure, strengthened by 'the surrender of national sovereignty, the pooling of security, economic co-operation,' etc. The nation-state, with its assumption of national sovereignty, was indeed inimical to the Committee's plans, as the group even intimated an eventual end to American national sovereignty once it had played its part in creating a world government, for 'the Pax Americana is [but a] preamble to the Pax Humana (pg. 110).'"

The outcome of World War II was the formation of the United Nations, World Health Organization, the splitting of Germany into 4 sectors, and long-term plans to destruct the United States through the similar methods that worked in post-Czarist Russia - attack the family structure<sup>82</sup> - but label this, feminist liberation, or in the 21<sup>st</sup> century: intersectionality and transgenderism. These social issues will be delved into in Chapter 5.

The European nexus of one world order to undermine nationalists and local government control pulls from the Chinese Communist gameplan for all humanity that are not Han, but particularly for the United States.<sup>83</sup> Subvert and destroy freedoms of religion, speech, arms, and due process, and label quickly anyone that protests this: DARVO applied (Deny, Attack, Reverse, Victim Offender), but geopolitically. By coercion and crisis amplification, the goal is to create a compelling fiction that the U.S. is *solely the bad guy*, if you are a CCP member, off despised *Western ideals*.

**This is but half right:** D.C. governmental agencies accrued a level of BLOB mendacious and malevolence to be responsible for current dysfunction worldwide. The CIA, and “its take down of governments” history, is a hallmark example. Except, these folks never do anything without various players, China, paralleling with the same destructive and entrapping actions (in the Global South), just these are less reported on. The two largest economies (as of 2024) have such thuggery down to “a science.”

The peoples of both countries are subverted and subservient to their governments. In China, there is 1.3 billion peasants with a ruling class of 376 top CCP members<sup>84</sup> and 96-98 million reported Party members.<sup>85</sup> In the U.S., there is approximately 135 million working class laborers with a government class of 22+ million reporting to the BLOB’s political, agency, and Wall Street class personnel that align with the CCP on most financial matters. Especially those matters that impact their wealth or ‘freedoms.’ If only these common peoples were willing to sacrifice for the future of Humanity and break the onerous shackles of mind, of body, *and of spirit*.

**In short:** the globalist objective is not different from Hitler’s; just the approach now is a so-called *enlightened dictatorial imperative*. Done first with softer persuasion techniques, towards a *Utopian Technocracy*, with a glossy sales pitch of less work ahead and being fully freed from your possessions to make *the utopia*. But a hierarchy will be always maintained; just not as obviously stated, as done under Hitler’s 3<sup>rd</sup> Reich attempt.

Klaus’s *World Economic Forum* forged business partnerships from a Davos, Switzerland ski-sloped, winter retreat over the past five decades. Economics, not bombs, do the needed damage, both direct, and collateral, to those that do not agree with this top-down subversion of humanity towards automation, identity, natural and human resource control. This is unfathomably close to 1930s technocrats’ master designs, now plausible.

A scenic parallel to Klaus’s Davos retreat lay in Hitler’s nine-month prison stay in excellent accommodations to dictate his book *Mein Kampf*:

“Such were the ideas of Adolf Hitler, set down in all their appalling crudeness as he sat in Landsberg prison<sup>86</sup> gazing out at a flowering orchard above the River Lech, or later, in 1925-26, as he reclined on the

balcony of a comfortable inn at Berchtesgaden and looked out across the towering Alps toward his native Austria...he would build on the shoddy foundations we have seen, and which he would rule with an iron hand. That one day he would build it and rule it he had no doubts whatsoever, for he was possessed of that burning sense...

A crude Darwinism? A sadistic fancy? An irresponsible egoism? A megalomania? It was all of these in part. But it was something more (90).<sup>87</sup> [My emphasis.]

Adolf, according to William Shirer's great work, noted three things worked in politics for the German Social Democrats: create a mass movement; the art of propaganda; the art of "spiritual and physical terror (Shirer, 22)."<sup>88</sup> Shirer focused on the last one as the faulty analysis derived from the racist prejudices of Hitler that spilled forth throughout *Mein Kampf's* pages. This three-pronged political observation came about in the early 1910s, echoing the 1999 CIA manual regarding nationalistic fervors congealing.

But this too developed under two *contrarian* forces that shaped early Nazis minds: occultism (Madame Helena Blavatsky) and psychological mastery (Freud) in the hacking of the human mind's id, ego and superego. Born in Dnipro, Ukraine (then Russia) in 1831, Helena Blavatsky was an occultist figure. Many still see her as a legitimate practitioner of occultism, founding the *Theosophical Society* in the late 19<sup>th</sup> century.<sup>89</sup> Her well-to-do station, she married a Russian general as teenager, only to "escaped to Constantinople" where her story muddles for a quarter century.<sup>90</sup> She then reappears in America as a séance leading mystic with wild and dubious writings. Her theosophical master work, *The Secret Doctrine* (1888), influenced leading Nazi adherents towards seven root races with the Aryan race having a specialness.<sup>91</sup> Nazi propaganda and early teachings of a superior race were born out of this sliver of Blavatsky occultist doctrine.<sup>92</sup>

Sigmund Freud, a Vienna-based practitioner, could of theoretically ran across a young, "bohemian" Adolf as he too was in Vienna (Shirer, 19-21).<sup>93</sup> Freud was then at the beating heart of the burgeoning psychiatric profession.<sup>94</sup> Freud, like Blavatsky, appealed to the 20<sup>th</sup> century power elites, who then pushed these ideas down to the poor and working class through the growing means of industrial mass media, then in its infancy stage of incorporating radio and film to a wider audience.

Sigmund's nephew provided the consumeristic pulse to that burgeoning mass media and propaganda in the United States. Edward Bernays, born in the same year that Madame Blavatsky died (1891), worked in Wilson's War Department<sup>95</sup>; attended the Versailles Peace Conference; wrote the book, *Propaganda* (1928)<sup>96</sup>; and was very popular with Paul Joseph Goebbels, Hitler's *Minister of Propaganda* for the 3<sup>rd</sup> Reich. Much later, Bernays did more off-the-books work for the newly-formed CIA under Allen Dulles.

Bernays wrote in his master work, *Propaganda*: “Propaganda is the executive arm of the invisible government.”<sup>97,98</sup> This pronouncement and explosive revelation in Bernays’s thinking is furthered in *The Century of the Self* (2000): “If Propaganda can be used for war, it can be used for peace (8:00).”<sup>99,100</sup> Bernays renamed his expertise as *public relations*.

Bernays provided other thoughts about his views on humanity to his daughter. Stating that, “people were stupid” and “easily misled”, but in book form, he stated these beliefs much more eloquently:

“They govern us by their qualities of natural leadership, their ability to supply the needed ideas and by their key position in the social structure. Whatever attitude one chooses to take toward this condition, it remains a fact that in almost every act of our daily lives, whether in the sphere of politics or business, in our social conduct or our ethical thinking, we are dominated by the relatively small number of persons - a trifling fraction of our hundred and twenty million [US Population in 1928] - who understand the mental processes and social patterns of the masses. It is they who pull the wires which control the public mind, who harness old social forces and contrive new ways to bind and guide the world (Chapter One, *Organizing Chaos*, 9-10).”<sup>101</sup> [My emphasis.]

Such thoughts (which could easily come from a Klaus Schwab speech at Davos) provided the background grist for which Hitler, if he was plausibly aware of Bernays, Freud or Blavatsky in the early 1910s, could *hack on about* in his incoherent rhetoric and written musings starting with *Kampf’s* publication in 1925.<sup>102</sup> Certainly, Goebbels had post-hoc conversations that reinforced what Hitler thought and described in *Mein Kampf* after Goebbels came fully into the Nazi fold, operating as its main messenger, by mid-1926 (Shirer, 123).<sup>103</sup>

Goebbels was intellectually trained in ways that should have been off-putting to the coarse and volatile future Nazi leader in Adolf. However, this was not the case. Nor was Goebbels instantly lovestruck with Nazism. But during the 1925-26 timeframe, that gradually turned solid, and firmly cemented into place for the duration of Joseph Goebbels’ life.

In Shirer’s words, “The diary of Goebbels is full of expressions of sympathy for Communism at this time (126).”<sup>104</sup> And, “on January 31, 1926, he told himself in his diary: “I think it is terrible that we [the Nazis] and the Communists are bashing in each other’s heads...” Goebbels attempted détente with the communists in an open letter penned in this timeframe along with attacks on the “nobles” in possession of German wealth. Meanwhile, Hitler’s Party was financed greatly by many of those very nobles, or their industries, that Goebbels proposed to nationalize (126-27).<sup>105</sup> Nevertheless, by that early spring, after various confabs with the ever-persistent and hyper-nationalistic Hitler, Dr. Goebbels was wooed to the cloth of Nazism, in perpetuity, happily or not (128-29).<sup>106</sup>

At the end of Hitler's Nazism, Goebbels elevated to Reich Chancellor of Germany on April 30, 1945. Just a day later, Goebbels killed his six children, wife and committed suicide.<sup>109</sup> Bernays outlived Goebbels by another 50 years, seeing the Soviet Union die a less fiery political death.

With the terrorizing of the mind and body historically affirmed into the Nazi playbook, Hitler was particularly interested in taking down bourgeoisie souls, of a particular sort, through lies and slander, even as he exploited them financially for his own benefit almost from the outset of Nazi Party's formation. He used a mass movement to physically terrorize any would-be opponents, particularly, *communists*, once so admired by Goebbels. Such terrorizing started with labeling ideas and particular people as extremists, radicals and otherizing them, creating a cauldron of hateful emotions that further inspired predictable chaos by amplifying and incentivizing aggrieved Germans towards a revolution. Such a preamble forewarned of useful methods in other 20<sup>th</sup> century totalitarian regimes.

Hitler's would-be obsessive and ideologically-adjacent offspring, Klaus, certainly used emotion with a harsh accent that has little warmth to focus on terrorizing through climate change: to promote and install *The Great Reset*. Klaus's WEF demanded an unhealthy control of media narratives and never provided any avenue for questions of his own non-governmental role, except by an adoring and well-coached journalistic outlets, particularly originating from China in CGTN's Tian Wei in her interviews of Schwab.<sup>110</sup>

Here, an overlay of Maoist principles, identity politics, springs to the fore. The WEF routinely called for "equity," while censoring people that do not agree with their agendas (comments off on their YouTube channel); such agendas are broad and many - and are pointed towards human activity to be properly restricted by technocratic bodies. Klaus has called China "a role model" for countries, particularly those now attached to the BRICS+ alliance bloc, like Russia, its major, nuclear-armed ally. The alleged inspiration of China - two systems, communism and capitalism - congeals off the hallmark saying of: "Chinese system with 'X' characteristics" label.



During Mao's Cultural Revolution, lasting a decade (1966-1976), categorizing people as either "red" or "black" with five identities each, created the resentment pot for 2 million plus to be publicly humiliated, and later, killed.<sup>111</sup> The "blacks identities" were the oppressors, and targeted by the "reds" in this cultural revolution.<sup>112,113</sup> The black identities are<sup>114</sup>:

- Landlords (dìzhǔ)
- Rich farmers (fùnóng)
- Counter-revolutionaries (fǎngémìng)
- Bad influencers (huàifènzǐ)
- Right-wingers (yòupài)

In 1966, Xi Van Fleet was seven years old. She experienced the violent trajectory of Mao's Revolution personally. From her personal analysis, Mao began his program to keep control of the CCP through activating the youth. Mao rallied the youth to counter those who threatened his power; as he lost influence after the democidal outcomes of *The Great Leap Forward*.

In an interview by Tucker Carlson, Van Fleet noted, as Yuri Bezmenov did, regarding generational indoctrination and the outcomes of misdirected anger supported overtly by Mao, the paramount head of the CCP:

"He [Mao] had 10s of millions of young people. That he had indoctrinated in schools for the past 17 years. They are ready to go...you are now mobilized to defend Mao. To defend communism...

They dismantled the criminal justice system. *No police.*

[Tucker]: 'Really?'

Just like *defund the police*. [In United States of America.]

The red guards could do anything. No consequences. Eventually, they start to kill. Kill their teachers. Kill their principals. They kill millions of people.

[Tucker]: 'Did the normal people, who are watching this...did anyone say anything?'

Nobody could say anything. Just like here [in America].

Why?

Because Mao openly supported them. Mao had eight rallies. To meet the Red Guards in Tiananmen Square. To declare he was their Red Commander-in-Chief. And those are his little Red Guards.

[Tucker]: ‘So there is no dissent at all? At all. And things get progressively crazier and crazier and crazier. Did people think that this is going to stop?’

No one knows. At first, it was somewhat peaceful. Because all they did was destroy the past. In Mao’s words, it’s the four olds:

- Old ideas
- Old culture
- Old customs
- Old habits

Get rid of them all. That included destroying all the statutes...Buddhist statutes. Christian statutes. Everything old must be destroyed...”<sup>115</sup>

Xi Van Fleet was taught that Mao was a “savior” for three reasons:

- Removed “Foreign Imperialism”
- Removed “Old Feudalism”
- Removed “Bourgeoise” or “Capitalism”<sup>116</sup>

Foreign imperialism forms the backbone of China’s *Century of Humiliation*.

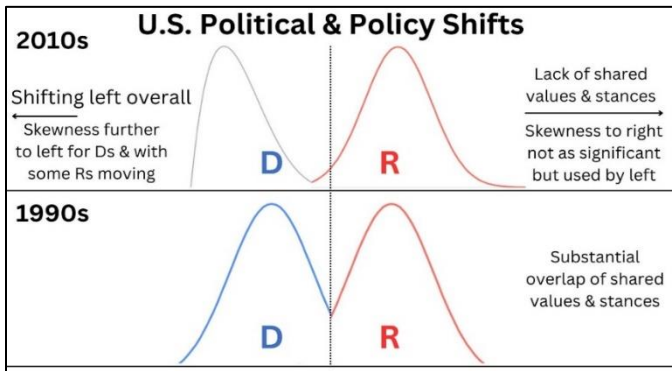
To the present day, to further degrade the commoner’s plight, those elite forces (GP) used the same identity mechanisms in the United States. By targeting middle-class businesspeople through the IRS, deploying disaster capitalism techniques, eliminating small farmers further, and infiltrating the Occupy/Tea Party movements to their discrediting, the GP attacked productive and independent people with resources to fight against their agendas using all the institutional organs available. An example: Amos Miller, a Pennsylvania Amish farmer, is being targeted by Biden’s Department of Agriculture regarding Miller’s distribution of raw milk (without a permit), accusing him of endangering the public.<sup>117,118</sup>

As alternative media channels became popular with the disgruntled, those alternative platforms (Odysee, Rumble, Bitchute<sup>119</sup>), were added to the watch list of the State. Defining platforms that allow freedom of speech as radicalizing, with Joe Biden noting that, “But no amendment – no amendment to the Constitution is absolute,”<sup>120</sup> in commenting on the 2<sup>nd</sup> amendment just 3 months into his administration. From the outset of the Biden’s administration, various agencies of the BLOB (DHS and FBI) defined “extremists” as: the *Making America Great Again* Trump-voting people.<sup>121</sup>

Those patriotic and nationalistic folks just two decades ago went to war for the elite (off falsified, WMD pretenses by Bush’s administration). Now to be “deprogrammed” as Hillary Clinton remarked in late 2023. In 2001, Clinton was a U.S. Senator who approved funding of both wars in 2003, sitting as well on the powerful Armed Services Committee from 2003-2009. As she began her first failed run for president, Hillary conveniently

reversed her war position as *The New York Times* pointed out in May 2007.<sup>122</sup> Senator Joe Biden did likewise regarding his votes for these criminal and costly wars.<sup>123</sup> But at present, their one-time supporters, are now, their domestically-targeted enemies. Just like Mao toggled off the short-lived, *criticism is welcomed, 100 Flowers* campaign<sup>124</sup> to encouraging his little Red Guards to attack his political enemies in delayed response to the agriculture catastrophe a decade into his leadership (1958-62).

Those who are called “right-wing,” as Hillary regularly intones, are labeled this way by the information agents (IA). The IA, aligned with those 1,000 WEF corporations, push social, identity and economic extremism across the world.<sup>125</sup> This is a “leftist” shift, not a right-led movement<sup>126</sup>; visible through media, technology, legal and medical silos adopting the WEF/UN 2030 Agenda. Extremism, caused by food shortages and corrupt politicians, fueled up the Sri Lankan riots and short-lived revolution in 2022. The WEF once pitched a Sri Lankan *utopia* in 2018 to magically occur by 2025.<sup>127</sup>



Pervasive throughout the Western World is the adoption of the oppressor-oppressed false dichotomy. After the Great Financial Crisis (GFC) in 2008, this narrative grew out of the luxury beliefs of the Bernaysian elitist few, who sit atop the wealth and power pyramid. From the Soros-funded meteoric rise of Obama as a “unifier,” despite his ties to Bill Ayers,<sup>128</sup> Obama’s goal was the “managed decline” of the U.S. as British journalist Gideon Rachman of the *Financial Times* wrote in 2011.<sup>129</sup> Obama’s messaging was one of groveling supplication and continuation of Bush’s domestic and foreign policy blunders, ranging from degradation of civil rights, domestic raids, faulty wars and poor trade policies. Charles Krauthammer wrote of the immediate supplication in October 2009:

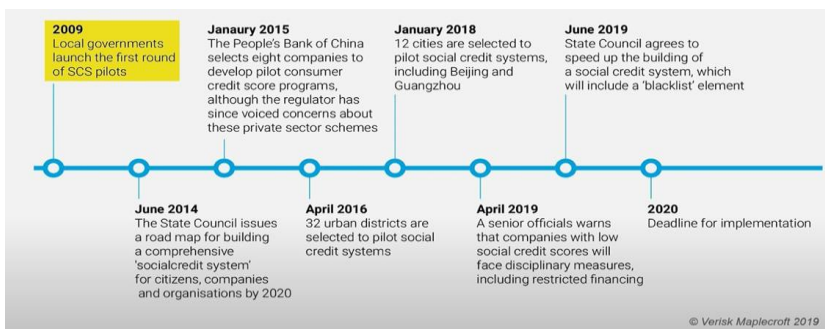
“Indeed, as he made his *haji* from Strasbourg to Prague to Ankara to Istanbul to Cairo and finally to the U.N. General Assembly, Obama drew the picture of an America quite exceptional - exceptional in moral culpability and heavy-handedness, exceptional in guilt for its treatment

of other nations and peoples. With varying degrees of directness or obliqueness, Obama indicted his own country for arrogance, for dismissiveness and derisiveness (toward Europe), for maltreatment of natives, for torture, for Hiroshima, for Guantánamo, for unilateralism, and for insufficient respect for the Muslim world.”<sup>130</sup> [My emphasis.]

At the same time, Obama had no trouble with FBI raids on whistleblower William Binney (NSA); or using drone strikes to kill American citizens without due process in foreign lands tied to the Arab Spring.<sup>131</sup> In April 2011, such due process degradation was installed on college campuses.<sup>132</sup> Award-winning CBS News journalist Sharyl Attkisson was targeted by Obama’s intel community regarding her critical reporting on *Operation Fast and Furious*.<sup>133,134</sup> Obama sent out VP Joe Biden to handle the Chinese and Ukrainian foreign policy portfolios to Hunter Biden’s verifiable personal benefit.<sup>135, 136</sup> U.S. manufacturing declines continued under Obama even with the passage of a \$700 billion infrastructure deal in 2009. This was also managed by Joe Biden, according to an April 2020 *NPR* article.<sup>137</sup>

The social media responses of the unhappy and unemployed masses worried the Globalized Parasites (GP) coming out of the GFC. But these too offered insights on how to divide them and finally destruct the Westphalian model to adopt a much harsher Chinese (CCP model) of authoritarian governance. From the ongoing crisis, came the long-term opportunity started many decades before.

First, energize China’s technological pathways through Silicon Valley (to build up China’s surveillance methods - where there is no constitutionally-protected liberties) to beta test a digital control grid. Some in Silicon Valley were all for this; others cooperated out of fear of losing market share and profits to competitors in China. Companies like Apple readily centered their operations abroad, whether manufacturing or financially.<sup>138</sup> Nonetheless, China’s social credit score and tracking successes reinforced desires to install this in the West.<sup>139</sup>



### China’s Social Credit System: A Warning for America (Valuetainment)<sup>140</sup>

Second, ubiquitous mobile technology came in parallel with better information gathering to enhance divide-n-rule (the *old social forces* as

Bernays noted). The exploitable opportunity hinged off these forces being promulgated into the social media, education and legal systems of Western Democracies. China's TikTok, like US-based Facebook or Twitter, is a data-collection, intelligence-infiltrated platform that targets Western youth for psychological manipulation of their reality. Billionaire Bill Gates (a common core funder and staunch Sinophile) moved to the forefront, installing debilitating educational narratives.<sup>141,142,143</sup> Done with subtlety, but done no less. Obama's 2011 *Dear Colleague* letter destructed due process rights on college campuses as this began the "guilty until proven innocent" inversion of U.S. legal norms. The *MeToo* movement later exploited this; as Hollywood's elite used #MeToo to maintain their relevancy in a dying industry lacking script originality and acting talent.

Third, with the 2012 Smith-Mundt Act propaganda dissemination changes, new control mechanisms grew to the BLOB's delight. The U.S. government saw their DARPA-supported creations - social media - worked well to destabilized targeted countries. These public communications platforms married well to *classic media methods* with the latter achieving the fall and arrest of Serbia's Slobodan Milošević during the Clinton administration.

This marriage was discussed by *Journeyman Pictures* in 2011. Their episode titled, "Does the USA Sponsor Revolutions?"<sup>144</sup> focused on the activities of WEF Young Global Leader and CANVAS director, Srdja Popovic<sup>145</sup>, and his sponsorship by the U.S. State Department, starting with Serbia's Milošević. Writing a 2013 opinion piece for the WEF, Srdja penned a globalist dream:

"To talk of the dramatic events in 2011 is to talk of collective action movements on a global scale - from the Arab Spring and Occupy Wall Street in the US, to election protests in Russia. If anything else, the image of a Russian activist holding up a sign claiming 'We are the 149%' in reference to the activism occurring all the way across the Atlantic is enough to show how the ideas of mass mobilization can permeate a worldwide consciousness."<sup>146</sup> [My emphasis.]

The 2011 Arab Spring, under Obama, produced the results the U.S. State Department desired. Driven by a new array of highly investable social media communication platforms, these assisted in U.S. regime change desires; led, in part, by Secretary of State Hillary Clinton and a key State Department Bush holdover, Victoria Nuland. But it was a July 2014 Julian Assange interview of Google's Eric Schmidt, a strong supporter of Hillary's 2016 run for the presidency, that pointed to State Department interference into social media platforms as early as 2009 under Obama. Assange wrote:

"It was [Jared] Cohen who, while he was still at the Department of State, was said to have emailed Twitter CEO Jack Dorsey to delay scheduled maintenance in order to assist the aborted 2009 uprising in Iran. His documented love affair with Google began the same year when he befriended Eric Schmidt as they together surveyed the post-occupation

wreckage of Baghdad. Just months later, Schmidt re-created Cohen's natural habitat within Google itself by engineering a 'think/do tank' based in New York and appointing Cohen as its head. Google Ideas was born.

Later that year the two co-wrote a policy piece for the Council on Foreign Relations' journal *Foreign Affairs*, praising the reformative potential of Silicon Valley technologies as an instrument of US foreign policy."<sup>147</sup> [My emphasis.]

Unfortunately for the U.S., their operational successes hit a snag in 2014, regarding Ukraine-Russia. Their long-standing policy, stated by NATO's first Secretary General and United Kingdom's Lord Hastings Lionel Ismay: "keep the Soviet Union out, the Americans in, and the Germans down,"<sup>148</sup> ran at odds with recent German-Russia energy partnering. The 2014 Ukrainian solution involved a messy color revolution that did not end with success. Neither Joe Biden nor Hillary Clinton were able to claim victory out of the Maidan. As such, the operation was to continue under a Clinton presidency.

The media made its choice clear to support Hillary over the upstart Trump. Big tech and the military agencies did likewise.<sup>149</sup> But for all their efforts, the commoners (non-bureaucrats) decided against the BLOB's preferred Globalist candidate. 2016's attempts to rein in the Western public's political desires failed, demonstrated by their Ukraine and Brexit defeats. The BLOB aggressively deployed its censorship and disinformation tools from that point forward. Chapter 6 will discuss the new disinfo network.

Below represents a few divide-n-conquer narratives. These pit people against each other over safety, security, health and identity groups.

- Capitalism v. Communism

Some are recent (MAGA v. Woke, Masks v. No Masks) while others are centuries old slicing up of people into groups to create the stew for war. The desired conflict element hinges off people that agree on 80-90% of reality, and policy, but then become absolute bitter enemies of one another over just one issue, labeling each other “stupid”, as Bernays surmised. This tactic is exploited by the GP; and now, the BLOB.

Both love to gin up particular factions to hate one another. By further tapping into a person’s psychological distress, through crisis after crisis, real *or manufactured*, the GP (and the BLOB) divvy up the population through their most powerful asset: social and mass media outlets.

The GP and BLOB’s power to create stress and crisis derives from an iron ownership grip on legacy media and 24-7 dissemination of propaganda. Their message can spread to many millions or billions inside a day, *a near superpower*. Their concerted efforts since 2012<sup>150</sup> was to *militaristically* alter and distort the media battlefield by: exponential escalation of loaded language and words; framing social issues without context; repetitive use of concise phrases - talking points; and blunt stereotyping of any dissenting voices throughout the Western World. These are but a few of the methodologies. In short, a militarized media operation aimed at domestic populations that did not agree with the GP or the BLOB technocrats.

Additionally, introducing widespread censorship *incrementally* (frog-in-the-boiling-pot) through “cancel culture” of people from Alex Jones to President Trump, and decrying all forms of government dissent as a foreign disinformation campaign<sup>151</sup> was achieved by the BLOB’s congealed entities and architectures. These networked entities were designed and populated for this task; and coordinated with social media as many later discovered. Investigators like Mike Benz, Michael Shellenberger and Matt Taibbi found out through the release of *The Twitter Files* in late 2022.<sup>152</sup>

The BLOB controls nearly all key media and deploys their info agents to stir up the pot. A March 2024 example: Film maker Michael Moore appeared on MSNBC to pit Jews against White Eurocentric Christians: victim-oppressor tactics.<sup>153</sup> This latest crisis hinges off U.S. funding the Hamas-Israeli chaos; but lacks the committed “MAGA” Christians to offer up undying military support as desired for the Ukraine-Russia war. The BLOB’s agenda needs a population to submit to all its narratives, including eager funding of the BLOB’s military operations and enlisting to die for another banker war.

This BLOB houses the WEF, who presented their own media control pitch. Published in a July 2020 *Building Back Better* document on *Media, Entertainment and Culture Industry*, the paper sought tighter messaging control techniques. Through targeted demonetization, and “sustainable” through leadership’s emotion and intuition, the WEF saw the pandemic as an opportunity to install “equity” throughout the media space. (Never let a crisis go to waste.) “Safety” is mentioned 14 times in this 26-page paper, with a laudable, if inherently predictable (and divisive) example that mentioned 2030 as the endgame agenda.

Media is the critical control pathway under any authoritarian regime’s rise and permanent installation. The GP has a full-court press on to make such occur inside their current window of opportunity prior to a worldwide debt collapse and their seizure of remaining assets. From the WEF report:

“We examined the demonetization of harmful content through initiatives such as the Global Alliance for Responsible Media (GARM), in partnership with the Forum’s ‘Shaping the Future of Media, Entertainment and Culture’ platform... (page 3)



Responsible leadership is a critical enabler of sustainable governance. Top leaders exhibit five elements of responsible leadership: 1) stakeholder inclusion; 2) emotion and intuition; 3) mission and purpose; 4) technology and innovation; and 5) intellect and insight... (4)

The pandemic precipitated ‘three years of transformation in three months’. It presented both an imperative to respond and an opportunity to change, to build back better. It provided an opportunity to revisit long-held assumptions, to rebuild, redesign and reprioritize to create a more trusted, prosperous, resilient and equitable industry (page 5).

Marc Pritchard, Chief Brand Officer at Procter & Gamble [WEF partner]<sup>154</sup>, announced a comprehensive review of the company’s media buying to ensure that it advertises on channels networks, platforms and programmes that accurately and respectfully portray black people. At Cannes Lions Live, he said the review will ensure its ads do not appear next to content it determines to be ‘hateful, denigrating or discriminatory’ and that ‘it’s time to create a responsible media supply chain that is built for the year 2030 - one that operates in a way that is safe, efficient, transparent, accountable and properly moderated for everyone involved, especially for the consumers we serve (page 7).’<sup>155</sup> [My emphasis.]

The Procter & Gamble citation above in this WEF paper links to a *Marketing Week.com* and referenced BLM (June 24, 2020) as motivated off George Floyd’s death.<sup>156</sup> Notably, the *YouTube* embed in the article is set to private. From the *Marketing* article by Matthew Valentine, he wrote:

“It comes amid global protests over racial injustice and the growth of the Black Lives Matter movement.”

‘Freedom of expression is a right, but civility is a responsibility, and we’re working with media providers and platforms to take appropriate systemic action,’ he [Marc Pritchard] added.

The company has already called on white people to step up and tackle racism in a campaign launched earlier this month.

When P&G’s standards are not met it will take its own action, up to and including stopping its media spend. Pritchard said that the last 100 days, as the Western world faced the Covid-19 pandemic and widespread disruption over race relations, “have brought clarity to what matters.’

...

He added that the death of George Floyd, and others, meant: ‘The brutal reality of systemic racism was laid bare and could no longer be ignored or set aside.’<sup>157</sup> [My emphasis.]

Pushing George Floyd’s death as systemic racism was but one of several phases of the 2020 color revolution in the United States. BLM is a Marxist-trained organization, as their 2014 founders were proud to tell people. Their immediate demands and desires were satiated by money (and spent thereafter).<sup>158</sup> Pledges came from the largest corporations in the United States, including Bank of America’s \$1 billion dollar offer made by CEO Brian Moynihan. Bank of America (BofA) is a key WEF partner. CEO Moynihan is heavily involved in the climate change dogma with BofA projecting \$150 trillion is needed to address it over 30 years.<sup>159</sup>

Opportunistically, an event while tragic (and based off a false narrative as to the underlying cause of death<sup>160</sup>) and to the legitimate disturbing malfeasance by Derek Chauvin (but was not murder) was hyperbolically used by political forces.<sup>161</sup> These resulted tellingly in further deaths, violence and property destruction tied to the very black people the WEF pretend *matter* to their social and climate causes. Below are just a few of the victims of the BLM-inspired protests during the aftermath of George Floyd’s death. More on this topic will be explored in Volume III.

The DISRN website listed 17 deaths in early June.<sup>162</sup> A Minneapolis Affordable Housing Project lost during the mostly peaceful protests.<sup>163</sup>

Yet again, this echoed Maoism, *with Fasco-communism characteristics*, and introduced the world to Schwab's Great Reset in June 2020. That explained why the public-private authoritarian regime of China is lauded as *the ideal model* to mimic for nation-states. (Many a Globalist parroted that line of thinking from Thomas Friedman to Justin Trudeau through to Joe Biden and his dementia-addled ramblings. Such parroting came out of a place familiar to Trudeau's ideological grooming: the Young Global Leaders program.<sup>164</sup>)

The young leaders cultivation was not a Klaus Schwab origination, but that of his lifelong mentor, Henry Kissinger. And by turn, Kissinger received his mentoring from William Yandell Elliott at Harvard.<sup>165</sup> From the *New York Times* obituary published in January 1979 by Barbara Campbell:

“Dr. Elliott directed the preparation of more than a 100 doctoral dissertations over his 38 years in Harvard's department of government, including those of Henry A. Kissinger, former Secretary of State; Pierre Elliott Trudeau, the Canadian Prime Minister; McGeorge Bundy, an adviser to Presidents Kennedy and Johnson, and the late Ralph J. Bunche, United Nations Under Secretary General.

...When he launched into a lecture on Karl Marx, for instance, he attacked what he believed were Marx's errors in theory so vehemently that he would draw hisses from students in the large lecture hall. He had been known to angrily hiss back. Yet a good number of the students emerged from his courses in government committed to following careers in political science.

...Dr. Kissinger, at the time of Dr. Elliott's retirement from Harvard, wrote of the professor: ‘Political theory to him was not an abstract subject to be studied historically or to be used as a demonstration of dialectic brilliance. It was an adventure where good and evil were in constant struggle to give meaning to existence and where epics seemed to be prescriptions for action.’”<sup>166</sup> [My emphasis.]

Elliott was born in Murfreesboro, Tennessee in 1896. He fought in World War I, graduated from Vanderbilt, and later, Oxford, and became a Harvard professor at age 28 in 1925. He became Harvard's director of summer school courses in Harvard's Government Department from 1950 to 1961.

Despite the hisses of his elitist Harvard students, Elliott was no enemy of Marx alone. He critiqued Rousseau's social contract as well, labeling it as no better than Marx's. Sean Stone, the son of controversial and independent filmmaker Oliver, wrote in his book, *New World Order*:

“W.Y. Elliott edited a political history of the West, wherein he contended that Rousseau's promise to ‘force men to be free’ (through an obligation to respond to the bidding of the General Will) was no better than Marx's

‘dictatorship of the proletariat,’ since both lacked respect for the individual’s moral responsibility. Elliott thus looked to the skepticism of Immanuel Kant, for ‘reconciling individual self-interest with moral obligation (pg. 47-48).’”<sup>167</sup>

With the formation of the United Nations and Declaration of Universal Human Rights in the late 1940s, Kant’s framework was more readily adopted; and then, immediately circumvented by those at extreme dialectical points. As the Cold War (1946-1991) commenced, it reflected an abandonment of core values - with “authoritarian” tools incorporated into the Western Democracies daily operations, adopting surveillance, CIA color revolutions to “spread democracy” against their counterpoint - the failed Soviet regime, that is now a more prosperous, less-indebted, Russia as of 2024. *Funny how that worked out.* Stone continued with his analysis:

“Thus, Elliott’s bipolar world-view of constitutional democracies opposing autocratic regimes across the globe must be questioned, as we are left with the ‘post-Westphalian world’ envisioned by Elliott and his intellectual allies, in their attempt to transform sovereign nation-states into universal states whose actions may no longer be circumscribed by national considerations or laws (pg. 50).”<sup>168</sup>

Elliott’s impact in creating world order acolytes aligns with close alignment with H.G. Wells’s *Open Conspiracy* (and Carroll Quigley’s dissection of Cecil Rhodes Roundtable). “The ‘objective of the Open Conspiracy’ would be met by increased socialization of international controls on raw materials, a centralized world banking system, ‘a world pax, a world economic control, and a restrained population (pg. 62).’”<sup>169</sup> [My emphasis.]

To achieve this plan, it was necessary to project, and protect, *British Imperialism* through the United States military and intelligence apparatus built up throughout the 20<sup>th</sup> and 21<sup>st</sup> century. And thereafter, get the needed nation-state dissolutions by subsuming all public resources, political and economic power into the hands of a global elite and their political and technocratic conduits. Sean Stone wrote:

“The phrase ‘New World Order’ is known to the literary world (via H.G. Wells’ 1939 book of the same title) as well as the political (it’s been used for decades by some of the most prestigious world planners, including Henry Kissinger and Zbigniew Brzezinski who have advised every Presidential administration in the past 50 years), and you’ll find it in books like *Of Paradise and Power: America, Europe and the New World Order* (2007) by Robert Kagan [the aforementioned BLOB-loving cohort] of the Bush regime, which bridge both the literary and political spheres. Then there’s *Toward a New World Order: The Future of NATO* by George Soros in 1993, a pamphlet which was printed to guide NATO toward its political goal. It’s also worth mentioning the 2010 documentary film directed by Jason Bermas titled: *Invisible Empire: A New World Order*

*Defined*, which has an informative 35-minute introduction showcasing the history and usage of the phrase ‘New World Order’ by statesmen and politicians, spanning the last century. In this day of instant-information on everything, how could people be kept in the dark about this topic? (pg. 15)<sup>170</sup> [My emphasis and additions.]

How is answered rather succinctly: *people don’t read*. That was the answer Council on Foreign Relations member, and CIA Director Allen Dulles bluntly stated, in release of *The Warren Commission*. The evidence found and written about regarding the Kennedy assassination pointed to parties with plenty to gain from Kennedy’s death other than Oswald. But the *magic bullet, lone gunman theory* was sold by the CIA-backed mockingbird media to keep the population unquestioning and stupefied into compliance. (One might hazard that US TV shows’ growth were a distraction method.)

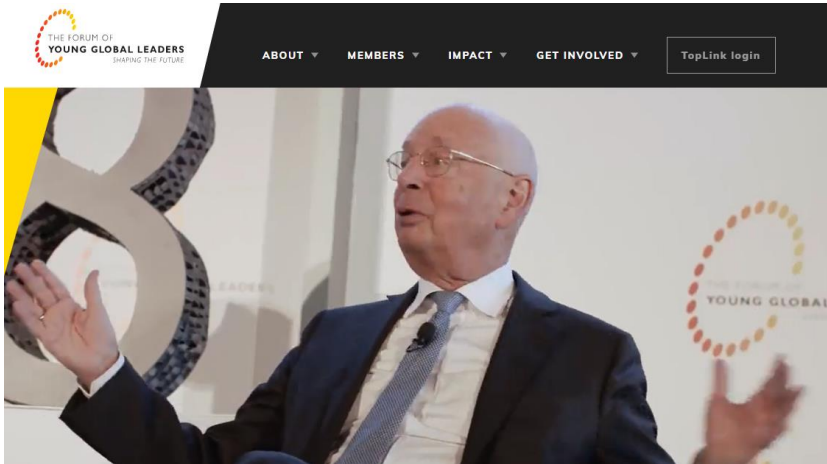
Stone reflected on how people in Americans went from questioning and reading (90% literacy in the colonies by the late 18<sup>th</sup> century) to being Kant slaves: “The adverse effects of the Prussian Education System which together transformed Americans from people who asked questions and sought answers, to a collective where self-responsibility is obsolete and individuals obey declarative sentences without question (pg. 16).”<sup>171</sup>

Elliot’s consistent desire was towards a strong international body to control inspection of what then was the newest weapon: nuclear bombs. His presence on Eisenhower’s National Security Council, position at Harvard, and predictive analysis on the USSR in the 1940s, gave him earned gravitas on geopolitics. Elliot “urged that America needed to continue testing in order to develop ‘cleaner’ nuclear weapons, which could be used ‘to fight limited wars’ and to ‘reduce the threat of human destruction to livable [sic] and bearable proportions (pg. 152-54).”<sup>172</sup> Such was a shared philosophical tenet of his renowned *new world order* student: Kissinger.

In Johnny Vedmore’s “The Kissinger Continuum: The Unauthorized History of the WEF’s Young Global Leadership Program”, the program is a mimicry of Kissinger’s International Seminar formulated out of Harvard and with CIA monetary and ideological seeding. Vedmore’s piece explored the deep history of key players spanning from World War II through the halcyon years of the United States to the forming of the current, CIA-installed, unstable ‘American Empire’ led *titularly* by Joe Biden in March 2024.<sup>173</sup> Vedmore wrote in great detail:

“However, the supposed mastermind of the project, the WEF’s lifetime leader Klaus Schwab, had himself already been helped into his own influential position by a very similar program run out of Harvard University that was heavily funded by the American Central Intelligence Agency (CIA). The Harvard initiative in question, often referred to as Henry Kissinger’s International Seminar, was one of several programs set up by senior members of organizations such as the Council on Foreign

Relations and the newly created CIA. In fact, during the post-World War II era, the United States was proactively creating many such programs with the intention of grooming potential young foreign leaders and installing them into positions of power. The main motive behind the establishment of these programs was ostensibly to combat and prevent communist infiltration of foreign states while also assuring that future global leaders would be amenable to US interests.

Originally, the United States created these secretive youth organizations with the aim of targeting potential future European leadership candidates. Yet, soon, no country in the world would be safe from possible CIA-sponsored political infiltration. In this article, we will examine one of the front organizations which used vast amounts of CIA money to fund various Harvard projects including Kissinger's International Seminar. We will learn who the people were who created these funding platforms, and we'll also look at other such educational initiatives, some still in existence today, which have helped American intelligence infiltrate governments worldwide.

In 1967, it was Harvard's own Humphrey Doermann who exposed that certain Harvard Summer School courses and initiatives were actually being funded via CIA conduits. Even though almost a decade of funding throughout the 1950s remained undeclared, it was revealed that, between 1960 and 1966, Kissinger's International Seminar received funding from three CIA conduits: The Asian Foundation, The Farfield Foundation, and The American Friends of the Middle East, the latter being one of the more well-known, influential and successful CIA conduits of the era.

The CIA funded Harvard-based International Seminar, and the conduits which the Central Intelligence Agency used to supply the forum with the necessary funds to run the program, are of great historical significance.

The American Friends of the Middle East (AFME) was not just a simple front organization used to funnel secret CIA money into their various projects, in fact, there were some very big names attached to this prominent post-war organization. The AFME was considered to be an ‘international educational organization’ and was formed the same year that Henry Kissinger launched the International Seminar at Harvard, in 1951. There were 27 men and women who made up the AFME, which was led by Kermit ‘Kim’ Roosevelt, Jr., the grandson of former-American President Theodore Roosevelt. The CIA had been formed in 1947 from what was originally the Office of Strategic Services (OSS) and Kermit Roosevelt Jr. was extremely influential in the early years of both organizations.

Kermit Roosevelt had been recruited by the mastermind behind the OSS, General William Joseph ‘Wild Bill’ Donovan, in 1941 and he was soon placed into the newly-created Office of the Coordinator of Information—the precursor to the OSS—as a special assistant to Dean Acheson. Working out of the State Department, Acheson, who was then Assistant Secretary of State, had been tasked during World War II with implementing President Franklin Roosevelt’s policy of undermining Axis powers while at the same time supplying economic aid to Great Britain. Kermit Roosevelt, who was distantly related to the president, had had an affinity with the Middle East from a very young age with the Daily Mail of Hagerstown in Maryland reporting in September 1948 that: ‘Mr. [Kermit] Roosevelt’s career as a writer began when he was a child with the composing of a prophetic poem, “The Lure of the East,” for the “American Boy” magazine. He was eleven at the time.’ Kermit’s father, also named Kermit, had been in the ‘shipping business,’ as mentioned in the latter article. This had meant that Kermit Jr. had travelled around the world at an early age.

Kermit spent the war years serving in the Middle East and Italy, travelling extensively throughout the war and was reported to have toured Egypt, Saudi Arabia, Syria, Palestine, Iran and Ethiopia...

Kermit Jr. had already been recruited by the OSS. Kermit Jr. continued to work for the OSS as a Middle East expert once the war had ended and he also began writing and editing the history of the secretive organization. By 1947, the OSS had become the CIA and Kermit was on the forefront of designing projects and programs for the newly-founded intelligence agency. He also seemed genuinely concerned for the situation in the Middle East, and soon took part in a lecture tour. That tour, whether sponsored by the CIA or not, saw Kermit argue passionately on behalf of those who were suffering in Palestine.

In December 1947, Kermit began a lecture tour on a paper he had written concerning the Middle East, entitled, ‘The Arabs Live There Too,’ which discussed the ‘Palestinian problem’ and looked at the basic issues between the Arabs and Jews who inhabited the region. The report, which was published in the Evening Post, warned that the situation deserves ‘more than a cursory glance from Americans.’ Kermit described Palestine as ‘the UN’s baby’ and stated that America had taken over the job as ‘nurse and governess’ of the region. The lecture tour was advertised in the Waukesha Daily Freeman on 22 December 1947, with Roosevelt stating within the articles: ‘Applying the principle of one of their proverbs, “My enemy’s enemy is my friend,” the Arabs might move into closer alignment with the Soviet Union [now Russia],’ going on to warn that ‘Arabs will not blame Russia (who voted for partition in the UN) half as much as they will blame Britain and the United States.’”<sup>176,177</sup>



Kermit's deep background in the Middle East put him at the head of field operations that kicked off the CIA's penchant and professional calling card of instigating coups and color revolutions. One of the first was "Operation Fat Fucker" with a band of people who are well-known in geopolitical and musically-connected history as Vedmore recounted the personnel involved:

"Egypt, at the turn of the 50s, was ruled by King Farouk, a notorious ruler who was already seen as corrupt in the eyes of most Egyptians. The project to depose him was led by the CIA's then-director Allen Dulles, alongside CIA Station Chief in Cairo, Miles Copeland, Jr.<sup>178,179</sup>; Secretary of State, Dean Acheson; and Kermit Roosevelt, Jr.—who was officially a CIA Operative at that time—with the original aim of applying pressure on Farouk to enact certain political reforms within his country. When the initial 'pressure' phase had failed, resulting in Farouk rejecting the American proposals, Kermit Roosevelt came up with an idea of how to orchestrate a peaceful revolution which would see both the required reforms enacted and the country more open to 'American control,' as historian Matthew F. Holland puts it.

Roosevelt met in secret with the Free Officers Movement, a nationalist revolutionary group, which was led by Gamal Abdel Nasser and Mohamed Naguib, and which was already planning to overthrow the government. On 23 July 1952, the coup d'état, which had been the brainchild of Roosevelt, saw Farouk forced into abdicating power and he was sent into exile in Italy. The CIA-led coup had successfully installed a new government, which they believed would be more amenable to further American infiltration. The CIA would then help the newly installed Egyptian government to establish the General Intelligence Agency, Egypt's own CIA clone organization."<sup>180</sup> [My emphasis.]

Kermit's leadership of AFME meant it was never clear cut about support of an Israeli state (Zionism); nor open about the lasting designs of the Middle East overall. Preferring instead a fair amount of instability amongst all the wide-ranging parties, keeping nation-states in a cycle of both need and hate of the United States government, while the U.S. was also in need of its blend of oil, specifically from Saudi Arabia. Keeping the problem alive could be seen as opportunistic, or as Vedmore stated: "the CIA in general would reap many benefits by creating a world which, if not in a state of perpetual war, was nearly always on the brink of perpetual war."<sup>181</sup>

Vedmore provided more background on interlocking histories, the Middle East and the birthing of Klaus Schwab's Young Global Leadership program.

"The AFME included some of the key people who were molding and influencing the post-war intelligence push. Even though we could find many interesting facts in studying all 27 members of the AFME, we now know that their interests focused on education and eventually resulted in the funding of a specific Harvard project that would create cadres of

future international leaders who were amenable to America's political interests and desires, including Klaus Schwab.

Just after World War II, there were many differing opinions within the American political establishment concerning what should be done about the 'Palestinian problem.' Although many of the members of the AFME may have been publicly anti-Zionist, an upsurge in Arab nationalism had been triggered by the Nakba, the ethnic cleansing of Palestinians following the creation of Israel in 1948. This initially resulted in a divide in public opinion, with many Americans eventually siding with the newly founded Israeli state and their occupying force.

Popular opinion among the Arabic countries was much less divided. The Arab League closed their offices in Washington DC—referred to as the Arab Office—in 1947, stating publicly that the United States had shown a 'complete and arrogant disregard for Arab rights, Arab interests, and Arab feelings.'

At this time, the United States were still heavily dependent on Arab oil and the supply of this oil also relied on America having good relations with the Arabic world. The US oil consortium ARAMCO could only continue benefiting from Arab petroleum if the US stayed on good terms with the Saudi king, Ibn Saud, who was an extreme anti-Zionist. ARAMCO soon setup an office in Washington so as to lobby government on behalf of the Arabs while also putting funds into educational institutions such as the Middle East Institute. [Ibn Saud met with President Roosevelt in early 1945 and made clear his opinion on the relocation of Jews to the Middle East. He was adamant this would not be received favorably.]<sup>182</sup>

Kissinger meanwhile graduated Harvard in 1951, and already could claim influential professors as close friends in W.Y. Elliott. Kissinger launched a magazine, *Confluence*. He garnered funding from the Rockefeller Foundation to publish it.<sup>183</sup> The CIA too kicked in many hundreds of thousands to what was Harvard's *International Seminar Forum* operated by the "guiding genius"<sup>184</sup> that of a young Henry Kissinger. The conduit for covert funding came through Kermit Roosevelt's AFME organization.

What Kissinger developed was a Harvard/CIA post-coup leadership forum, though to what level Kissinger knew that at its outset would be a matter for others to settle. Nevertheless, Vedmore noticed the pattern:

"While Allen Dulles, Kermit Roosevelt Jr., and their secret army, were organizing and enacting coup d'états in country after country, other CIA-linked organizers and contributors were beginning to create the infrastructure that would allow them to recruit, train and install young European leaders into positions of power, leaders who they believed were unlikely to be susceptible to potential Soviet influence. Harvard was not alone in its funding of such projects."<sup>185</sup>

Vedmore quoted the countering force to the CIA, the communist platform, published as, *The Essentials of Lenin, Vol II*: “Every sacrifice must be made, the greatest obstacles must be overcome, in order to carry on agitation and propaganda systematically, perseveringly and patiently, precisely in those institutions, societies and associations—even the most reactionary—to which proletarian or semi-proletarian masses belong.”<sup>186</sup>

The intrigues of the Cold War era were played out in the battle for hearts and minds: capitalism versus communism. The impressionable youth that are open-minded and easily-led (or misled) on the intellectual battlefield of college campuses, seminars, and junkets that were covert/overt CIA-KGB operations with the glitzy appeal to those who wanted to be “of service.” To which country, or rather, which ideology, depended on the pitch given by the lecturer and the benefits package (both disclosed and undisclosed). The perks of the job - for both ideologies - leaving one’s conscience back in a small town one likely came from to join an organization *whose mission was never quite clear*, not even to its leadership, but nevertheless, was highly important to *national security*. Or more relevantly: a global world order.

To wit, the CIA countered, developing Kissinger who then molded Klaus Schwab, from Klaus’s own telling about Kissinger’s inspiring his life’s work. Schwab’s full ‘coming out’ event was in 1992, titled “Mandela in Davos.”<sup>187</sup> The event included the likes of Bill Gates, Tony Blair, and Vaclav Havel, among the “all-world” leaders in this top draft class of WEF for life. This as the Rio conference launched the climate focus on the United Nations’s *Agenda 21*. Klaus’s rise into the current pantheon of unelected world leaders has been a steady and assured climb. He received The Atlantic Council’s inaugural Global Citizen Award in 2010.<sup>188</sup>

Kissinger’s close proximity to Schwab’s 1992 *Global Leaders of Tomorrow* program, later rebranded as the WEF Young Leaders, never faded from importance. As Vedmore noted: “Astoundingly, the Tel Aviv-based Dan David Foundation that awarded Schwab the \$1 million which was directly used to create the Young Global Leaders program had one extremely significant member of note on their board, Henry A. Kissinger.”<sup>190</sup>

Then, as the Prince of Wales, King Charles III pushed Schwab’s Public-Private Partnership agenda, that Schwab stated was, “the world’s foremost catalyst to promote PPPs”:

“None of what I have said so far is very original, and I am not trying to suggest that I have a Utopian answer to the many problems humanity is destined to face. All I want to emphasize is that, as it says in the Bible, ‘Man does not live by bread alone.’ We are not just cost-effective machines that can be made ever more efficient. There is another dimension that has to be recognized. That is why the message I want to leave you with today is that business is uniquely well placed to take a lead and to get things done, but in partnership with local communities, governments, non-governmental organizations and other representatives of the voluntary sector.” [My emphasis.]

For many years, the WEF Young Leaders were prepped, penetrating positions of power in nation-states and embedded in 450 cities worldwide.<sup>191</sup> The UN specifically partnered with the WEF in the summer of 2019 to move along their *Agenda 2030*.<sup>192</sup> Such infiltration works to steer policy, at a critical juncture, when the time was ripe. That ripening time came in 2020, as the book: *COVID-19: The Great Reset*, was released not unlike the virus (as a package) itself. This introduced humanity to the not-so-hidden world the Global Parasitic Elites (GP) want for themselves with a

few billion slaves or serfs (to remain) under their thumb permanently while pitching this as a way to address *Climate Change* and human inequities.

More importantly, the number of corporations ranging across all sectors of industry (automotive, banking, electronics, health & pharma, to social media), countries (China, Saudi Arabia, United States, et.al) and cities and leaderships should cause alarm. At the cusp of 2024, this alarm is more clearly the case as routinely people are reviewing the WEF's talking points.

To give scope and name a few faces of this agenda, this was released from the WEF Global Shapers 2020-21 Annual Report:

“In August 2020, 2,500 inspiring young leaders participated in the first-ever virtual Global Shapers Annual Summit to inspire, support and scale collective action. Members enrolled in a five-day programme featuring plenary sessions with leading experts including Al Gore, Ellyn Shook, Yo-Yo Ma [,Jane Goodall, Christine Lagarde] and Lindiwe Mazibuko, along with community activities to build relationships and workshops to share best practices and plan projects.”<sup>193</sup> [My emphasis.]

Among political leaders, their messaging foreshadowed a dystopian and destructive future that Klaus has trained well into his graduates. MP Ida Auken is in the “Danish Social Democratic Party and Former Minister for the Environment, *Young Global Leader*, World Economic Forum.”<sup>194</sup> Her fictional account below seeded the 2030 dystopian future, whether inside (or outside) of *15-minute cities* (not mentioned directly here).

A potential in this vision, Chinese technocrats bring in the key communist tools - population surveillance, social credit system and goods-making clout - whereas, Klaus's group will lead an elitist-run, fascist military with perpetual social engineering and digital monetary policy to control the West. These two partners will guised themselves under the “climate change” and “save the world from itself” veneer of creditability. Such a Fasco-Communitic marriage comes with a plethora of incendiary social issues of race, gender, and trans-sexualism thrown in as a veritable catch-all to appeal to (and to divvy up as well) the uninitiated masses. Offering something to everyone; but nothing that truly matters to the GP elite.

Ida Auken wrote on November 11, 2016 this *World Economic Forum* publication to its website (since deleted)<sup>195</sup>:

“Welcome to the year 2030. Welcome to my city - or should I say, ‘our city.’ I don't own anything. I don't own a car. I don't own a house. I don't own any appliances or any clothes.

It might seem odd to you, but it makes perfect sense for us in this city. Everything you considered a product, has now become a service. We have access to transportation, accommodation, food and all the things we

need in our daily lives. One by one all these things became free, so it ended up not making sense for us to own much.

...

Environmental problems seem far away, since we only use clean energy and clean production methods. The air is clean, the water is clean and nobody would dare to touch the protected areas of nature because they constitute such value to our well-being. In the cities we have plenty of green space and plants and trees all over. I still do not understand why in the past we filled all free spots in the city with concrete.

...

### **They live different kinds of lives outside of the city**

My biggest concern is all the people who do not live in our city. Those we lost on the way. Those who decided that it became too much, all this technology. Those who felt obsolete and useless when robots and AI took over big parts of our jobs. Those who got upset with the political system and turned against it. They live different kind of lives outside of the city. Some have formed little self-supplying communities. Others just stayed in the empty and abandoned houses in small 19th century villages.

Once in a while I get annoyed about the fact that I have no real privacy. No where I can go and not be registered. I know that, somewhere, everything I do, think and dream of is recorded. I just hope that nobody will use it against me.

All in all, it is a good life.

...

Author's [Ida's] note: Some people have read this blog as my utopia or dream of the future. It is not. It is a scenario showing where we could be heading - for better and for worse. I wrote this piece to start a discussion about some of the pros and cons of the current technological development. When we are dealing with the future, it is not enough to work with reports. We should start discussions in many new ways. This is the intention with this piece." [My emphasis.]

Ida gets around the obvious questions of the dystopic hellscape she depicted. She somehow thought by further qualifying statements lessened the impact of what she painted. But it revealed the pernicious ideology behind Klaus Schwab's marriage to Xi's Communism with growingly and visible fascistic characteristics.

- No private property
- No privacy
- Data collected 24-7

- No ability to reform governance and political dissent not allowed
- Cities dominate, rural life is considered, harsh, 19<sup>th</sup> century backward
- “Lost along the way” - what is the euphemistic intent of this phrase?

James Lindsay<sup>196</sup>, a PhD mathematician (Tennessee, 2010) and the author of *Race Marxism*<sup>197</sup> wrote a November 2021 tweet thread about this dialectical concept merged together:

“Hypercapitalism, as it’s called, is fascism with Communist characteristics. Like in China but with fascism leading instead of Communism leading (China has Communism with fascistic characteristics). This is in line with the Leftist dialectical approach to everything.

We’re seeing two versions on the dialectical synthesis of Communism and fascism (Communofascism and Fascocommunism), in which Communism absorbs corporatist markets, logic, and governance and uses them abusively. That’s why I just call it Communism. In the end, it is.

These two systems, meant to be the two global powers (Oceania and Eastasia), are intentional dialectical inversions of one another so that they can collide and resolve more contradictions on the way to Utopia. If you understand the Theory, it’s artificially elegant.

Same thing is happening with CRT and whiteness studies. Blacks are said to have double consciousness imposed upon them, so whites need it too. Blacks approach it through conscious Black Pride. Whites through conscious self-shame. Dialectical inversions of one another.”<sup>198,199</sup>

Ida Auken envisioned an entire ‘utopia’ that James Lindsay merely theorized about.

In order to reach this *2030 Agenda*, from the mid-2020s on, harsh sacrifices regarding people, property, privacy, and their human rights naturally flow from Ida’s 2016 WEF published discussion. She expressed, tellingly, about this authoritarian fusion of two, 20<sup>th</sup> century, nightmarishly genocidal political ideologies. One surmised her belief is more wholeheartedly accepting of the “losses along the way” from her *class consciousness perspective* than she’d care to admit aloud. (A test run: Shanghai (25+ million) were locked down brutally by the CCP according to the BBC.<sup>200,201</sup>)

Hitler’s Beer Hall Putsch happened on November 8, 1923. Now over a century ago, Hitler fired a pistol during that failed coup night, a false start that led to his incarceration and publication of his prison scribblings in *Mein Kampf* (*My Struggle*). The atmosphere that gave him even the remotest inkling of a chance to start this revolution lay in the outcomes five years prior.

On November 11, 1918, Germany formally surrendered and then faced the onerous, if seemingly warranted, Versailles Treaty dictates. It was only a short while before those dictates - financial reparations in hard collateral, gold marks (Shirer, 58), and restrictions on any militarization - both hamstrung the economy and wounded the pride of the German military warriors that came home defeated, and betrayed, in their personal view. (Some have offered that Germany never fulfilled any of those reparations. But even the perception that they did had its economic impacts, as hyperinflation occurred.)

The Weimar Republic was a disastrous failure and extremism grew like a weed from government corruption, weakness, and ineptitude in handling the peoples' rights and economic concerns. Weimar had this from its start. Versailles was the main focus of the Germans; Shirer reminded that the German leadership had been equal to the Western powers in demands:

“German memories did not appear to stretch back as far as one year, to March 3, 1918, when the victorious German Supreme Command had imposed on a defeated Russia at Brest Litovsk a peace treaty...[that] deprived Russia of a territory nearly as large as Austria-Hungary and Turkey combined, with 56,000,000 inhabitants...a third of her railway mileage, 73 percent of her iron ore, 89 percent of her total coal production...moreover, Russia was obliged to pay Germany an indemnity of six billion marks (57).”<sup>202</sup>

The Weimar Republic that agreed to Versailles soon violated the military side of the agreement. This while meting out justice unevenly from Shirer's recounting of treason charges aimed at political adversaries on the left. That fueled up Hitler's ambitions knowing consequences were minimal for extremist attempts predominating from the right then (Shirer, 60).<sup>203</sup>

Likewise, the German mark fell like a stone over the course of 1921-1923. From 75 to a U.S. dollar in 1921, to 400 in 1922, it started 1923 at 7,000. This currency collapse paired with the French occupation of Germany's Ruhr, their industrial epicenter, and home to most of Germany's coal production. Non-violent strikes were supported by the Berlin government; others however went the sabotage route with other methods that the France decided were unacceptable, and countered with a range of options from arrests to death sentences. More spectacularly, the freefall of the currency to 4,000,000,000 marks to the dollar by November 1923 was the defining backdrop to which Hitler saw as a German crisis becoming his golden opportunity (Shirer, 61).<sup>204</sup>

Adolf's opportunity was nixed barely out of the womb, failing in a night. However, a more familiar group benefited handsomely as Shirer reflected:

“The inflation could have been halted by merely balancing the budget - a difficult but not an impossible feat. Adequate taxation might have



achieved this...Instead of drastically raising taxes on those who could pay, the republican government actually reduced them in 1921.

From then on, goaded by the big industrialists and landlords, who stood to gain though the masses of the people were financially ruined, the government deliberately let the mark tumble in order to free the State of its public debts, to escape from paying reparations...Moreover, the destruction of currency enabled German heavy industry to wipe out its indebtedness by refunding its obligations in worthless marks...

The masses of the people, however, did not realize how much the industrial tycoons, the Army and the State were benefiting from the ruin of the currency (Shirer, 61-62).<sup>205</sup>

[Financial side note: The escape of taxes, by the wealthiest, who could actually pay them, should be observed. The ability to raise taxes and cut spending, at the same time, is not even in the basket of delusional abilities of 21st century technocrats in D.C. Though these administrators, from the U.S. Congress to Treasury, hustle the public on their technological expertise and abilities to do such things together. **But never do.**

But, as of the last quarter century, the idea of balancing budgets, as shown by the rapidly growing U.S. national debt, does not even enter the worldview of modern technocrats with their reliance on Modern Monetary Theory (MMT) dogma. Some contend, rightly, there is no error here in policy, rather: the intention is to break the U.S. monetary system - and destroy the United States dollar as the world currency of settlement.<sup>206]</sup>

To put further meat on the bones of Shirer's assertions, renowned author in his own right, Antony Sutton, wrote voluminously in his lifetime about the Soviets and the Nazis and the financial manipulations coming from Wall Street to Washington to London. In the work, *Wall Street and FDR* (1975), Chapter 3, Sutton provided the names, plots and organizations that drove the Weimar Republic into the brutal genocidal hands of a WWI corporal with a hatred of capitalism, kleptocrats, and in lockstep: benefited greatly those that allowed this totalitarian rise. Sutton discussed the 1918-23 Weimar crisis and the financial benefactors of this weak German regime:

“Reparations have an effect on the balance of payments similar to imports. They require either taxation or deficit spending to offset the drain. If the course of deficit spending is followed, the result will be inflationary, and this was the course followed in Germany.

Germany was obligated by the Allies to make recompense for all damage to private property, except in Russia and to pay all costs of Allied troops on German soil, but no maximum limit was set on the demands. Germany had forthwith to surrender 100 billion gold marks, with payments of one billion gold marks annually after 1921. The final payments plan worked out at the ‘London Ultimatum’ in May 1921 reflected these harsh and

impossible terms and so provided a clear incentive to inflate to remove the burden of direct payments...

The so-called experts...Owen D. Young of the General Electric Company. J.P. Morgan, with Thomas N. Perkins and Thomas Lamont as alternates.

Worthy of note that businessman on the German side...were...in November 1918 a group of the Reich's most prominent businessmen, comprising Stinnes, Albert Voegler (then director of the Gelsenkirchen Mining Co., Ltd.), Carl Friedrich von Siemens, Felix Deutsche (of German General Electric), Director Mankiewitz of the Deutsche Bank, and Director Salomonsohn, of the Diskontogesellschaft, financed the movement of a Hitler forerunner...

The pertinent point is that the Felix Deutsche mentioned was a director of German General Electric and the American reparations representatives included Owen D. Young of General Electric [as well].

The policies that led to the ruinous German inflation were initiated under Chancellor Wilhelm Cuno, who was, immediately prior to becoming Chancellor, the president of Hamburg-America Line (HAPAG). Two of Cuno's co directors at HAPAG were Max Warburg, Hamburg banker and brother of Paul Warburg, member of the Federal Reserve System Advisory Board in the United States, and John von Berenberg Gossler, a member of the German advisory board of Franklin D. Roosevelt's United European Investors, Ltd. [UEI]

Cuno was dismissed as German Chancellor in August 1923...Cuno came from a business circle that was able and willing to take pecuniary and personal advantage of the German inflation.

...the ultimate collapse of the German mark in 1923 ruined the German middle class and benefited three groups: a few German big businessmen, a few foreign businessmen who were in a position to gain advantage from the inflation, and the rising Hitler movement. As president of United European Investors, Ltd., Franklin D. Roosevelt was among those foreign businessmen who took advantage of Germany's misery for their own gain.

In...*Wall Street and the Bolshevik Revolution*, we identified personal links between Wall Street financiers and Bolshevik revolutionaries...The precisely established links previously implicated the then German Ambassador to the United States, Count von Bernstorff, and his friend Adolph von Pavenstedt, senior partner in Amsinck & Co., who was 'for many years a chief paymaster of the German spy system in this country.' Amsinck & Co. was controlled by the J.P. Morgan, John D. Rockefeller, and other New York financial interests through American International Corporation.

[Moreover] Adolph von Pavenstedt and Edmund Pavenstedt...were also members of another financial house, Müller, Schall & Company. And it is at Müller, Schall that in 1922 we find Franklin D. Roosevelt at his [UEI] United European Investors, Ltd.

[Notable: Pavenstedts likely competed with the Roosevelts in Puerto Rican sugar properties, as Sutton keenly surmised, based on both families interest held in Caribbean sugar companies.]”<sup>207</sup> [My emphasis.]

Sutton reflected on UEI’s stock ownership details, correspondence, maneuvers, and the cash out by FDR in May 1926. There were early investigations on the shady dealings of UEI, particularly its involvement with the “Roberts-Gould element (39)”<sup>208</sup>; and FDR was made aware of this by July 29, 1922 through his advisor then: Louis Howe. Correspondences by Gould to FDR pointed out that the “jealous bankers whose scheme we hurt, and whose plans were upset. Had we not issued [stock] today we would have failed (40).”<sup>209</sup> To be fair, as Sutton is, FDR was just a name attached to draw in investors to the scheme; not a “master mind (41)” as Gould described FDR to butter up his more prestigious cohort. Both advantaged themselves off Germany’s inflationary misery through Cuno’s timely position as Chancellor, Cuno’s board seat at HAPAG coincided with Gossler’s relationship to FDR’s UEI’s German operation.

History is said to rhyme not repeat. The ‘Spanish Flu’ of 1918 took more lives than all of World War I, but had an origin story: manipulated so as to ignore the elites (Rockefeller’s) involvement.<sup>210,211</sup> With that ‘flu’, a series of destabilizing events built up for the next cauldron of chaos: Europe’s World Wars, 1918 Virus, Versailles Reparations, German Social Unrest, Weimar Inflation Spiral, USSR’s policies and the Ukrainian Holodomor, Nazi

and Communist Extremism, Coups, Conflicting Ideologies and the Rise of Dictatorships Globally. This kept the common population in a state of flux, instability, stress, and thirsty for any answers sans that of another war. World War II is said to be just the continuation of World War I. War is the destructive child of Money that is the devilish spouse of Power.

Great wars are the unfortunate and devilish ploy of those malevolent enough, and financially secure enough, to achieve its ends at the highest social price; and persuasive enough, to get a population to accept war as the only path left to them while under the extremist spell of *Mass Formation*. Bombarding a population with propaganda and disinformation - *to define an enemy* - while conveniently shifting all the State's sins onto this defined enemy, *whether internal or external*, is done to this day. (The United States government (and particularly, its agencies), have done this now for decades through media outlets and supported NGOs, such as the National Endowment for Democracy, a CIA front-facing organization.<sup>212</sup>)

An interesting and hidden aspect was war intentions congealed well before a shot was fired in World War I. In *Hidden History, The Secret Origins of the First World War* by Gerry Docherty and Jim Macgregor (2014), from their opening chapter, introduced the major players and their agendas:

“The three staunch British imperialists who met that day, Cecil Rhodes, William Stead and Lord Esher, drew up a plan for the organisation of a secret society that would take over the control of foreign policy both in Britain and, later by extension, the United States of America: a secret society that aimed to renew the Anglo-Saxon bond between Great Britain and the United States, spread all that they considered good in the English ruling-class traditions, and expand the British Empire's influence in a world they believed they were destined to control.

It was the heyday of both Jack the Ripper and Queen Victoria. The latter, having confronted her anti-Semitic prejudices, began a personal friendship with a member of the Rothschild banking dynasty, which played such an important role in what was to follow.”<sup>213</sup>

The financial forces were readily aware of early 20<sup>th</sup> century economics that did not benefit them if those economics outcomes continued. Simply, it was about the velocity of money and the faltering of an empire.

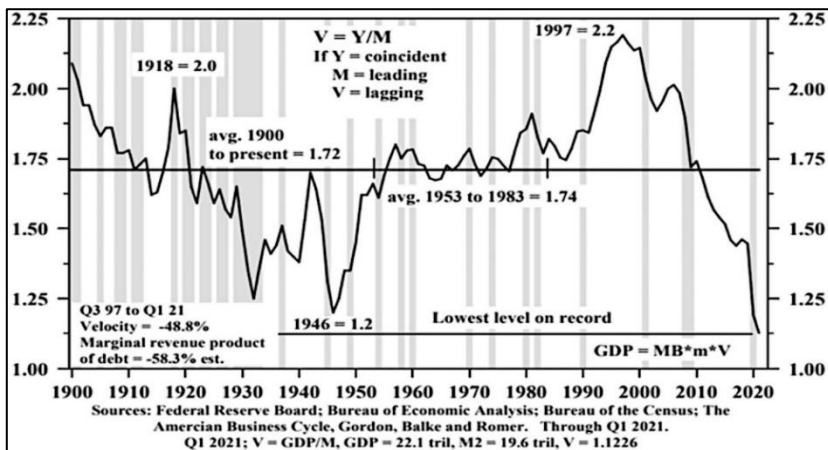
David Rogers Webb, author of *The Great Taking* (2023), partly premised his collateral seizure theory on money supply growth and GDP stagnation triggering powerful forces to reshape the world.<sup>214</sup> In a confirming quote, University of Chicago economic professor Milton Friedman was cited from his study of monetary history. Friedman, who garnered a Nobel Prize in 1976 for his economic insights, wrote *A Monetary history of the United States, 1867-1960*, with Anna Schwartz.<sup>215</sup> In it, we find this observation:

[W]e know enough to demonstrate rather conclusively that . . . velocity [of money] must have declined sharply from 1880 to World War [2]<sup>16</sup> . . .

Webb continued on with these insights to support his theory:

Collapse in VOM is exactly what was unfolding from the 19th century and leading up to the Great War. Within a few years, the Russian, Austro-Hungarian, and Ottoman empires ceased to exist, as did the Qing Dynasty. The German economy was destroyed. Then followed the Great Depression, the Second World War, and the slow collapse of the British Empire. No populations were unscathed. There were no winners. Or were there?[3]<sup>217</sup>

“Money is an extremely efficient control system. People order themselves upon money incentives, and thus difficult, dangerous and energy intensive overt physical control need not be employed broadly. But the money control system breaks down at the end of a monetary ‘super cycle’, with collapse in the Velocity of Money (Velocity, or VOM). This is a multi-decade process.[2]...

Velocity × Money Supply = GDP. Lower Velocity results in lower GDP.

VOM later peaked in 1997 at 2.2 at the end of a stable, overall period begun in 1953 at the outset of NATO. Since 2008, the money supply has greatly increased [M2], but economic output [GDP] has not moved in accordance to historical [VOM] average (1.70-1.74). Instead, the VOM cratered drastically downward to 1.12 as of 2021.

Meaning: there is substantial pain coming to the world if prior super cycles are indicative of velocity of money and growing mass instabilities. This will be the topic of the last chapter: Reserve Banks & BlackRock.

History echoes well on personalities here. Similar motivations, *but not the inevitable sequencing*, or the coarse Hitlerian word choices. Heir apparent Klaus Schwab “wrote” and published two books. *COVID 19: The Great Reset* and *The Great Narrative* exploited the crisis position to create the *Davos Man* opportunity that he and his acolytes parroted since March 2020. (Later, we will see chief WEF partner, Larry Fink, kicked into overdrive BlackRock’s *Going Direct* plan as early as September 2019.)

This landed in concert with Xi Jinping’s avid promotion of the CCP’s lockdown desires, making the titled book quite a social engineering tell. Released just three months after the pandemic began in the West and timed up with George Floyd’s death, this triggered ‘phase two’ of the color revolution. These tombs spelled disaster for Western social values, small businesses, and non-technology, farming and other entrepreneurial folks.

Klaus Schwab and Thierry Malleret wrote in *The Great Narrative*:

“The pandemic was one such thing. Many international organizations and individuals had warned for years that a pandemic would occur but, despite this, it took most of the world by complete surprise. Now (December 2021), almost two years since it began, the pandemic seems never-ending and continues to drag on. We hope that the COVID-19 crisis will soon be over, but will it...Pandemics as a social and psychological phenomenon are not episodic: they linger for years. A historian of science and medicine puts it this way: ‘We are living in the COVID-19 era, not the COVID-19 crisis. There will be lots of changes that are substantial and persistent...We will be dealing with many of the ramifications of COVID-19 for decades.’ ”<sup>219</sup> [My emphasis.]

Notice in this brief passage, the ability to reinforce the crisis, uncertainty, longevity, and emotional stress within these tension-filled words. The repeating of pandemic or COVID-19 is not by accident. The historian cited references back to a *New York Times* article (by Gina Kolata) who quoted Allan Brandt, a Harvard University professor. The word choice: *drag*, *linger*, *never-ending*, *warned*, *persistent*, *decades*, give the impression of no hope can be had regarding this deeply manufactured catastrophe. But that is the *emotional* and *psychological operations* point of the WEF.

Pandemics do not *drag on* for decades. The individual repercussions from those that died, no doubt, have such personal impacts, but wane considerably with time as with any grieving process. The small businesses shuttered (by design) are of course a uniquely felt problem as well here. But several pandemics have occurred since 1918, and those were by orders of magnitude more deadly (deaths/world population); and handled far better by those populations, despite less technology, less medicines, and even, less preparedness.

In other words: in spite of all our technological advancement, we allowed ourselves to be manipulated and maneuvered over a virus that was “engineered,” both cellularly and psychologically, for even greater impact on Humanity’s trek, artificially, for the GP’s and BLOB reasons.

Jeffrey Tucker, a libertarian at the *Brownstone Institute*<sup>220</sup>, noted the 1968-69 H3H2 “Hong Kong Flu” caused none of the overblown responses.

“That generation approached viruses with calm, rationality and intelligence. We left disease mitigation to medical professionals, individuals and families, rather than politics, politicians and government.”<sup>221</sup>

This pandemic was not about truth or the real intentions of Klaus Schwab’s *Great Reset* narrative. Schwab continued on into the next paragraph:

“Lessons from past pandemics...Among them are the acceleration of automation and innovation, rising inequalities, the growing power of tech and surveillance, the rising rivalry between the United States and China, the partial retreat from globalization, the economic paradigm shift, and an increasingly fractious geopolitical landscape.”<sup>222</sup> [My emphasis.]

Notice only one of the above is neutral *linguistically* (innovation), while the remaining list is conflict-added for emotional impacts to the reader. Predictive programming on how *The Great Reset* is to actually occur.

Klaus and colleagues deployed such high-level concepts, regarding massive changes, corporate-government cooperation while destabilizing disliked populations (most humans) - those who are natives to a country and complained too much about Globalization’s ills. This plan was half-birthed in the 1970s by his mentor, Kissinger.<sup>223</sup> Klaus’s schtick bares a striking semblance to early 20<sup>th</sup> century corporate-socialists, namely, the writings of Brookings, Filene, and intertwines with Hegel’s formulations.<sup>224</sup> These concepts fueled up Hitler’s speeches prior to his *Beer Hall Putsch*.

*Klausian changes* are not uniquely desired by rational populations; and often it is the youngest (and most inexperienced) that are molded to think immediate change is needed by *the intellectuals* that have deeper agendas regarding maintaining or acquiring power. Many, typically older persons, in non-academic situations, are rather contented by slow progressions, and for good reasons. Their understanding is acquired from their parents’ stories, readings or impactful experiences on what happened in Germany from the Spring of 1918 to the Spring of 1945 (or the Eastern Bloc under the Soviets). The helter-skelter, empty promises reinforced a slowness to change. That *Five-Year Plans* ushered in radical privations. And radical regimes undoubtedly fueled up World War II (and are doing so) *yet again*.

The wisdom of older adults knows intuitively something now is amiss. Even if they don't always have the scientific or academic backgrounds to decipher the thrust behind it, they inherently feel the social, political and economic echoes churning up the extremism. Their time in the world milieu provides a coarser education on the twists and turns of history. But this experience is education, nonetheless; and this is to be valued dearly. When one of Klaus's acolytes, Canadian Prime Minister Justin Trudeau, noted this in 2020: "This pandemic has provided an opportunity for a reset."<sup>225</sup> Many wiser adults were instantly aware this was not about addressing the pandemic at all and had a worldly knowledge to know that.

Sutton in *Wall Street and FDR* foreshadowed the *old-becomes-new* hustle of corporations with their bureaucratic technocrats operating together: "the principles of corporate socialism are but a thin veneer for the acquisition of wealth by a few at the expense of the many (70)."<sup>226</sup> To understand how such men behind the curtain perform, one need only review a brief biographic sketch of Edward Filene provided by Sutton.

Filene, "served as chairman of the Metropolitan Planning Commission of Boston, promoter of people's banks, and provided assistance to various cooperative movements. Filene was active in the Red Cross and the U.S. Chamber of Commerce; a founder of the League to Enforce Peace; a founder and later president of the Cooperative League, subsequently renamed the Twentieth Century Fund; and a member of the Foreign Policy Association and the Council on Foreign Relations (70)."<sup>227</sup>

Filene was an FDR acolyte, campaigner (prior to Filene's death in 1937 at 77), and a writer of two noted books: *The Way Out* (1924) and *Successful Living in this Machine Age* (1932). Filene wrote (as Sutton cited), "the finest possible public service of businessmen is that rendered in and through the private businesses of the world (71)."<sup>228</sup> [My emphasis.]

Sutton nodded to Kissinger - "the road to peace is the balance of power" argument - was but a Fileneian adoption of a "19<sup>th</sup>-century formula (71)" that Sutton surmised, even if Kissinger did not, leads to chaos and world war. This formulation - that balance achieved as such can be observed as fleeting when the trap lays in the passing of two such powers *in balance*.

The linguistic tells shown above echo those of a *more refined 21<sup>st</sup> century Hitler*, as the political originations are now to the *Left*. (This too exploited the Left-Right political paradigm for divide-and-rule of populations across a host of decision vectors in people's lives. Health decisions and racial appearances being the most operative since 2020 started. Much akin to the Nazis usage of those vectors in the 1930s, regarding health and hygiene laws and the Jewish, non-Aryan people as their targets for brutality.)

Identity politics firmly reestablished in America under Obama. That was by design, a top-down sabotage of burgeoning political movements (*Tea Party*



and *Occupy Wall Street*). Race, gender, sexuality, and handicaps are hustled from WEF-attached corporations like Anheuser-Busch InBev.<sup>229,230</sup> Much like Mao, the ever-altering American vicissitudes of intersectionality, a victim points and virtue-signaling hierarchy of slivered out chaos has commoditized people towards brands for sale and scourge. Dupable customers to physically carve up in hospitals before they leave their middle school years. The propaganda issued created more narcissistic wine moms that do little thinking. This while their husbands or 'sperm donors' are left either to submit to their Munchausen's by proxy behaviors, or be fined, jailed, or censored for calling their once, easily identifiable offspring by their birth names. Instead, they allow their minor child to post whatever gets them the most clicks on *TikTok*, the Chinese app, prior to *transing*.

Transgenderism and racism are the information agents daily push - as the White House hosted influencers and promoted their most twisted administration lackeys to appeal to an aberrant and fringe minority with visible personality disorders. These events followed up on Biden's executive orders tying funding to compliance with U.S policy regarding "conversion therapy" for other countries.<sup>231</sup> Conversion of minor boys and girls, *who can't be sure what they want*, is promoted by the AMA and the APA as "gender-affirming care."<sup>232</sup> The same medical professionals that did so terribly in regards COVID-19 deaths wants minors, with underdeveloped neurological decision-making skills, to make permanent, life-altering decisions. These actions once led to incarceration for medical malpractice. By contrast, other powers (BRICS+) are not promoting these "ideas." One will never hear mentioned a Chinese mom transitioning her child.

Back to Sutton's work. He finished up his *Genesis of Corporate Socialism* chapter with a summary of what is the 2020s march towards *Agenda 2030*. BlackRock's Larry Fink advocated for these ideas since Wall Street's craven antics (dissected in the documentary, *Inside Job* (2010)) destroyed the U.S. housing market by 2008, but received a trillion dollar FED bailout thereafter:

"What was the philosophy of the financiers so far described? Certainly anything but laissez-faire competition, which was the last system they envisaged. Socialism, communism, fascism or their variants were acceptable. The ideal for these financiers was 'cooperation,' forced [behaviors] if necessary. Individualism was out, and competition was immoral. On the other hand, cooperation was consistently advocated as moral and worthy, and nowhere is compulsion [social engineering] rejected as immoral. Why? Because, when the verbiage is stripped away from the high-sounding phrases, compulsory cooperation was their golden road to a legal monopoly. Under the guise of public service, social objectives, and assorted do-goodism it is fundamentally 'Let society go to work for Wall Street (72).'<sup>233</sup> [My emphasis and word insertions.]

Again, the total corporate-government control path is but a merger of a host of ideological underpinnings: Fascism, Communism, Technocracy, and even an AI-generated, Aesthetic *Atheism*. Klaus eagerly promoted a 4<sup>th</sup> *Industrial Revolution* in a 2015 *Foreign Affairs* publication. In that article, Klaus buried the idea of *Transhumanism* subtly at the end:

“We need to shape a future that works for all of us by putting people first and empowering them. In its most pessimistic, dehumanized form, the Fourth Industrial Revolution may indeed have the potential to “robotize” humanity and thus to deprive us of our heart and soul. But as a complement to the best parts of human nature—creativity, empathy, stewardship—it can also lift humanity into a new collective and moral consciousness based on a shared sense of destiny. It is incumbent on us all to make sure the latter prevails.”<sup>234</sup> [My emphasis.]

A 21<sup>st</sup> century Borg mentality combined with 19<sup>th</sup> century-based political economies fuels the visions of the most vocal and well-placed elite.<sup>235</sup>

~

To pivot back over a century, Hitler’s ideas, as Shirer reviewed them, came out of a cauldron of philosophic, paganistic, and racist brews stirred up to a formative boil on the cusp of the 20<sup>th</sup> century. Shirer’s masterwork delved deeply into the men (and a woman) that directly, (or much more likely), indirectly shaped the destructive mind and musings of Hitler.

Over the course of the 1800s, the names fueling the ethnic fires of what became World War I and II ideological-driven tenets, ran back to Hegel, Treitschke, Marx, Nietzsche, through Richard Wagner and even, to an Englishman: Houston Stewart Chamberlain. Hegel, of the dialectic, is undoubtedly the most visibly enduring into the present day (particularly in the world’s educational systems) with the *Thesis*, *Antithesis*, and *Synthesis* control framework. But in the hands of the global parasitic (GP) elite, the dialectic formulated more simply as: create the problem, exploit the reaction, and offer up the solution. Rinse and repeat until the long-sought agendas are accomplished through a *constant ideological struggle*. Shirer stated cleanly this came out of Hegel’s deep adoration of State power:

“To Hegel the State is all, or almost all. Among other things, he says, it is the highest revelation of the ‘world spirit’; it is the ‘moral universe’; it is ‘the actuality of the ethical idea...ethical mind...knowing and thinking itself’; the State ‘has the supreme right against the individual, whose supreme duty is to be a member of the State...for the right of the world spirit is above all special privileges (98).”<sup>236</sup>

Hegel’s role in Marxism is not to be diminished here. Shirer minimized Marx throughout his Reichian reflection (appearing just twice in 1,273 pages), possibly due to Marx’s endpoint: a “no State” outcome. Nevertheless, Shirer linked the “inspiration” of Hitler and Marx together as being drawn

from Hegelian philosophies (98).<sup>237</sup> Hegel approved of a *Super State* - that is what the United Nations is, and from which greater direct control evolves under the guise of offering “One [World] Health.”<sup>238</sup>

In Marxism, the ‘anarchic’ no-State desires are nearly implausible when applied to *Modernity*.<sup>239</sup> Even the ‘best’ examples of communism (the final action desired by Marx, the removal of the State) prematurely finishes with a one-party authoritarian rulership firmly in place. For such ideologists with political power, the ultimate expression of Marxism is not as appealing once the enormously risky and deathly domination of a submitted people has been pursued, so obsessively, to an assured, slavish end. Their *final task is not sanely achievable* - because enemies arise that will gladly ensure that death befalls the leader that steps aside *even in the slightest*. By then, as well, the psychological and physiological pressures (required struggles) may well drive one and all towards a (Godless) madness.

Humanity as such is uniquely flawed, and will continue to be, but is an amazing collection of ideas and achievements. When its better organizing principles - a healthy, and prioritized, tension of individual liberties and rights primacy over a limited and stated social contract held by a modest nation-state - are adhered to. This has, and can be, achieved successfully for nearly all peoples. However, such requires a stern diligence, and a vigilance, that most populations grow careless and complacent about; and ignore the inevitable circumstances of elected corruption, criminality and perversion of their nation-state. This will result in the crucial times we see unfolding, *exponentially*, towards an *Age to end all Ages*, if the worst of humanity get their way.

Easily seen, but rarely discussed, nation-states and adjoining world financial markets expand fiat currency (velocity of money noted above), perpetuate wars, sabotage their industrial and agricultural bases, and ignore subversions of their culture, language, beliefs (which all people have - but not all beliefs are worthy of wide adoption). These nation-states are destined for death through the embers of socialism. These socialist treks appeal to the most corrupt and the most derelict in their duties in promoting a life of meaning, instead of a quest for power and control.

~

One offers here that a political *psychopathy* is key to this repetitive problem, that of: high intellect, motivation and malevolence, in amply supply, and fueled by the immense wealth and positioning to easily perverted lesser political sociopaths, personality-disordered, or even Milgram-ordered “normal” people.<sup>240</sup> Such political psychopaths may run in families, ruling through intermediaries over many generations.

About 1-4% of the human population has psycho-pathological characteristics<sup>241</sup> that drive societies into the dustbin. Hitler, and his lesser

minions, were so disordered from their action and writings. When these conscience-absent people acquire positions, and normal people failed (or ignored) their pathological lies, constant deflections, and threats via 3<sup>rd</sup> party entities (police and military), their power will amplify and destruct social fabrics once held dear. Once defeated, thereafter, the evolutionary game *resets*; and it takes 3-4 generations to spin the wheel of genocidal world chaos and war up again through these humans *without a conscience*.

This new 21<sup>st</sup> century set of psychopaths, do not appear ideologically pure, but are parasitic in all their behaviors, and will use any manipulation to acquire success, relief from boredom, et. al. Many have labeled this phenomenon: “elite overproduction.”<sup>242</sup> Nevertheless, those GP elite have garnered enough political or positional power over a much larger population of humanity to create the appropriate backdrop for enormous social destabilization, leading again to large-scale wars. Only this time, the methods are more psychological and information control derived, so as to not expose the GP elite to horrible life-ending judgments by the populace.

Sadly, financial markets and run-of-the-mill opportunists fuel these megalomaniacs-in-the-making towards such wars and mass death treks. It is not capitalism - here to blame - it is a psychopath’s seat in cronyism, corruption, cartel and monopolistic behaviors, that all trek towards global totalitarianism without any governor *on behaviors* called a *justice system*. The large intrusions by government (elite-populated), that will “please the mob” with fiat currency and keep their lies pathologically spinning to keep their ruling places at the top. Thus, as well, divide-n-rule, invisible enemies, blame shifting to the lower classes, support this much larger point: psychopathic-level behaviors grow from disastrous mismanagement and routine and ignored criminal activities.

Beyond Marx, Nietzsche provided the vision of an operative present-day pillar towards a “European Union and world government (99)”<sup>244</sup> that has come to a partial fruition. In this iteration of world domination, the Chinese are exploited as a “power base” from which the European elite have befriended. This after those oligarchs were their military masters

during the 19<sup>th</sup> century as we will explore in further chapters. Nietzsche, as Shirer reinforced, was a useful ideological prism to channel all sorts of spite for the common Nazi; and one speculates, these common themes flow now through Klaus Schwab, originating in a Nietzschean worldview:

“There was some ground for this appropriation of Nietzsche as one of the originators of the Nazi *Weltanschauung* (worldview). Had not the philosopher thundered against democracy and parliaments, preached the will to power, praised war and proclaimed the coming of the master race and superman - and in the most telling aphorisms? A Nazi could proudly quote him on almost every conceivable subject, and did. On Christianity: ‘the one great curse, the one enormous and innermost perversion... I call it the one immortal blemish of mankind... This Christianity is no more than the typical teaching of the Socialists... ‘There is no such thing as the right to live, the right to work, or the right to be happy: in this respect man is no different from the meanest worm.’ (100).”<sup>245</sup> [My emphasis.]

This same Nietzschean thought pattern is directed at all Christians in the Western World. A disdain for their principles and the targeting by the Biden administration, who is a friend of Klaus Schwab, going back many years.<sup>246</sup>



Klaus’s intellectual guru and messaging comes through his own Goebbels: Yuval Noah Harari. Nicknamed “the prophet,”<sup>247</sup> Dr. Harari is an Israeli historian and author of *Sapiens and Homo Deus*.<sup>248</sup> Harari speaks and writes as an observable atheist (or at least is ascribable as a secular Jew). Former President Obama is a noted fan of Harari’s written works.

Yuval has made many 4<sup>th</sup> industrial revolution proclamations, though he states that “I’m not a technologist.” In a video montage, Yuval’s statements reflected a deeper agenda that is not about most humans benefiting or improving their station on this Earth. Notable are ideas that “drugs and video games” are best way to handle populations that will no longer have political power as part of the “useless class.”

“One of the biggest things right now is a shift in authority from humans to algorithms to AI. Now, this decision about you, about your life, is done by an AI...We may see humankind splitting into biological castes or classes...and most humans will become economically useless and politically powerless. Already today, we are already seeing the creation of a new class of humans, the useless class... A class that has no military or economic usefulness, and therefore, no political power.”<sup>249</sup> [My emphasis.]

Yuval suggested that: “Free will is over”<sup>250</sup> and “human rights are...just a fictional story.”<sup>251</sup> These ideas flowed naturally out of many 19<sup>th</sup> century German thinkers and supported their intellectual ammunition for what came about in the first half of the 20<sup>th</sup> century.

At present: The 21<sup>st</sup> century’s main leaderships and world actors reinforced that individual and human rights, free will, are not of any concern for them to maintain. Your economic usefulness may pivot on ultimately, as Yuval said aloud: “What do we need so many humans for? (1:48-1:53)”<sup>252</sup>



“If populist leaders attacked the liberal order, but said:  
*‘We have an idea for a **different order**, here are the **universal values** we believe in, and these are the **global institutions** we support’*  
...then we could have talked about it.

But they **destroyed the order**, without offering anything to replace it. And when you destroy order, what you get is **disorder, chaos, violence.**”

On January 31, 2024, Harari takes to Twitter critiquing populism.<sup>253</sup>

Sharp critics, namely the departed Dr. Zev Zelenko<sup>254</sup>, observant of the Jewish faith, noticed Yuval's messaging was not much differentiated from Nazi ideology, stating that "all the Godlessness that has been bred in academia... and the embodiment [of that]...and [Yuval] is the leader of the movement to destroy God (23:16-24:04)."<sup>255</sup>

Paraphrasing Zelenko's thoughts, Yuval promoted *Übermensch*, or overman. This superman evolved from Nietzsche's 1883 work (*Thus Spoke Zarathustra*) and the thought processes once backstopping Nazi ideology. What Yuval called "the useless class", the Nazis labeled these souls as: the *Untermensch* or "inferior people."

Nietzsche's forewarned (and this captured his heartfelt desires) as Shirer's *Rise and Fall* tome linked this back to the mindset of Hitler:

"...the coming elite who would rule the world and from whom the superman would spring. In *The Will to Power* [Nietzsche] exclaims: 'A daring and ruler race is building itself up...The aim should be to prepare a transvaluation of values for a particularly strong kind of man, most highly gifted in intellect and will. This man and the elite around him will become the 'lords of the earth (101).'"<sup>256</sup> [My emphasis.]

Hitler "appropriated" the *Lords of the Earth* (101) phrasing that predestined the *New World Order* mantra reiterated by late 20<sup>th</sup> century men from Kissinger to George H.W. Bush to Obama and to his former Vice-President Joe Biden. This obsessive desire runs well beyond them and deep into the first quarter of the 21<sup>st</sup> century as it nears a nexus of completion. It is almost as if there were no other desires to be expressed aloud by such politicians. And behind them lay a more sinister group of power players.

A further analysis of the amoral aspect of this economic design is provided in Sutton's *Genesis of Corporate Socialism*. In highlighting Rockefeller and Morgan, Sutton foreboded the rise of Larry Fink, Bill Gates, or Jeff Bezos, who are but *face men* for the likes of a Rockefeller:

"Old John D. Rockefeller and his 19th century fellow-capitalists were convinced of one absolute truth: that no great monetary wealth could be accumulated under the impartial rules of a competitive *laissez faire* society. The only sure road to the acquisition of massive wealth was monopoly: drive out your competitors, reduce competition, eliminate laissez-faire, and above all get state protection for your industry through compliant politicians and government regulation. This last avenue yields a legal monopoly, and a legal monopoly always leads to wealth.

This robber baron schema is also, under different labels, the socialist plan. The difference between a corporate state monopoly and a socialist state monopoly is essentially only the identity of the group controlling

the power structure. The essence of socialism is monopoly control by the state using hired planners and academic sponges. On the other hand, Rockefeller, Morgan, and their corporate friends aimed to acquire and control their monopoly and to maximize its profits through influence in the state political apparatus; this, while it still needs hired planners and academic sponges, is a discreet and far more subtle process than outright state ownership under socialism. Success for the Rockefeller gambit has depended particularly upon focusing public attention upon largely irrelevant and superficial historical creations, such as the myth of a struggle between capitalists and communists, and careful cultivation of political forces by big business. We call this phenomenon of corporate legal monopoly—market control acquired by using political influence—by the name of corporate socialism (62).”<sup>257</sup> [My emphasis.]

Our 21<sup>st</sup> century timeframe repeated this monopolistic control model guised under a WEF “public-private partnership” (PPP) moniker. The purposeful rise of the technocrat - hired planners and academic sponges - formed a *combined model schema*, a corporate behemoth like Apple and the U.S. government (through agency “powers”): fascism married socialism. Meanwhile generated irrelevancies - the 2010s politically-pitched battles over racism, domestic terrorism, and false fascism *from the common political right* are conveniently divisive tropes sold by the overwhelming, partnered-with-WEF media partners and their advertisers.

WEF partner companies numbered well over 1,000 worldwide as of this writing. The list includes all sectors of industry. Their influence campaigns invited thousands of participants from government and corporations across the world to Davos yearly to hold both public (and private meetings) where one can tell, from the public pronouncements, the goal is not better governance. Rather, it is better control of world populations without their consent or negotiation. Due to Switzerland’s so-called “neutrality” - it openly violated this precept in 2022, siding with NATO over the Russia-Ukraine War - since 1815, Davos provided an untouchable site from which to run world policy without the questions of commoners mattering at all.<sup>258</sup>

The WEF website provided a treasure trove of white papers and glossy idealistic approaches to the world’s problems and key to their agenda is nature, health and climate change control plans.<sup>259</sup> Klaus’s organization provided translation into Mandarin Chinese at the bottom of their articles too.<sup>260</sup> (Many of their WEF Partners are China-based & in the Global 500.)

Olivier Schwab, Klaus’s son, is married to a Chinese woman and is the managing director of the WEF in Beijing, China.<sup>261,262</sup> Notable here, Klaus’s daughter focuses on *gender issues*. Transhumanism is a favorite topic of the father Klaus, the marriage of man, machine, genetic modification and Artificial Intelligence (AI) that will lead to Nietzsche’s “superior man.”



Not to be ignored, the Chinese are collaborating with the Forum's initiatives across a spectrum of technologies for Western world's full adoption. In 2017 and 2022, Xi Jinping provided the opening speech at the annual meeting at Davos.<sup>263</sup> This coincided with Xi's 5-year term renewal as the CCP's paramount leader after he came to power in 2012.

In October 2022, Xi became the CCP's leader *for life*, and likely displayed his power in the removal of former paramount leader Hu Jintao, his immediate predecessor.<sup>264,265</sup> According to *The Guardian*, "The incident was not broadcast in China, and Hu's name was effectively scrubbed from the internal internet, inside the country's great firewall."<sup>266</sup> Hu's last significant public appearance was at the funeral of CCP leader Jiang Zemin's funeral in December 2022.<sup>267</sup>



One suspects Klaus's family does not run afoul of the CCP leadership as Xi is completely in control of the military, a power well beyond even Mao's primacy after 1949.<sup>268</sup> It has been routine for Xi to crackdown on billionaires that regard his regime badly or bring any humiliation to it: Jack Ma (Alibaba)<sup>269</sup> and Ye Jianming (CEFC).<sup>270</sup> Of course, internal challenges will never abate under such top-down dictatorial regimes.

In a telling paragraph, from *Bloodlands* by Timothy Snyder, one gets a sense of how 'a world order' is but a bone fought over between two, doggedly democidal ideologies: socialism and fascism. Snyder wrote that:

"The Soviet Union was the only realistic source of calories for Germany and its west European empire, which together and separately were net importers of food. As Hitler knew, in later 1940 and early 1941 ninety percent of the food shipments from the Soviet Union came Soviet Ukraine. Like Stalin, Hitler tended to see Ukraine itself as a geopolitical asset, and its people as instruments who tilled the soil, tools that could

be exchanged with others or discarded. For Stalin, mastery of Ukraine was the precondition and proof of the triumph of his version of socialism. Purged, starved, collectivized, and terrorized, it fed and defended Soviet Russia and the rest of the Soviet Union. Hitler dreamed of the endlessly fertile Ukrainian soil, assuming that Germans would extract more from the terrain than the Soviets.”<sup>271</sup>

When ‘World Order’ is sought, submission is sought against the people caught in the upheavals to achieve it. Now those two ideologies are merged in a 21<sup>st</sup> century obsessive quest for completion of world order.

War drums began their beat around the same time Klaus’s latest book was wrapped up in late 2021. With Ukrainian family origins, Undersecretary of State Victoria Nuland landed at the beachhead of Ukraine’s policy for more war in 2021.<sup>272</sup> After the 2014 Maidan Revolution, with her then handy work completed for Obama and Biden<sup>273</sup>, she toured the think tank circuit (Brookings) just prior to being selected, yet again, by Biden.

Nuland, a noted neocon and married into a radical sect<sup>274</sup> that designed and deployed the response to the *War on Terror* circa 1999-2005<sup>275</sup>, visited Moscow in October 2021, just a month after the U.S. chaotically left Afghanistan with billions in weaponry abandoned and 13 dead soldiers.<sup>276</sup> This is routinely left out of publications, such as *Foreign Policy*, who published a February 5, 2022 piece that avoided Nuland’s October visit:

“In December 2021, the Russians published demands to, effectively, rewind the clock on most of the last quarter century of developments in European security. Sergei Ryabkov, the deputy foreign minister responsible for representing Russia in talks with the United States in mid-January, had no authority to engage on any topics at all unless Russia’s maximalist demands were accepted ex ante. That isn’t the position of a diplomat who has come to do diplomacy; it’s the position of a guy who’s part of a setup.”<sup>277</sup>

The overlooked October meeting lit a fire under Putin’s geopolitical positioning in Ukraine as Nuland made threats to wreck the entire Russian economy.<sup>278</sup> Putin’s memory and resume dates back to his KGB days and his KGB boss, paramount leader Yuri Andropov, and his predecessor, Leonid Brezhnev.<sup>279</sup> Putin’s geopolitical chess maneuvers<sup>280</sup> ramped up with his thuggish, pragmatic, ruthlessly protective mentality regarding his quarter century as “ruler” of Russia. Such U.S.-based threats made were not taken lightly as 100,000 Russian soldiers were activated by 2021’s end.<sup>281</sup> Especially coming from a Ukrainian that has a *Russian obsession* and the means to carry them out called the U.S. military alongside its deeply embedded intelligence operatives from the CIA.<sup>282</sup> The last bit was confirmed by a *New York Times* report in February 2024.<sup>283</sup>

20th century history did not leave others in this 21<sup>st</sup> century international power struggle out of the mix. Canada's Deputy Prime Minister Chrystia Freeland's family played a big part in the Nazi-Ukraine-Soviet struggle Snyder calls the *Bloodlands*. In May 2022, Tablet Magazine's Jeremy Appel wrote:

"Freeland's Ukrainian grandfather on her mother's side, Michael Chomiak, did nothing of the sort. During the War, he edited *Krakivski Visti*, a Nazi propaganda rag in occupied Krakow that was printed on a press confiscated from a Jewish newspaper. Freeland, of course, is not her grandfather, nor is she responsible for his actions. But she is responsible for bringing him up at every opportunity to portray him as a liberal democrat who profoundly influenced her politics."<sup>285</sup>

Freeland's story backdrops in Ukraine. She is fluent in Russian.<sup>286</sup>

The story surrounding Visti, is complicated by Ukrainians easy pivots towards Nazi support to achieve their aims countering the Soviets. Appel reflected the special relationship of the *Krakivski Visti* paper:

“While most nationalist papers in Nazi-occupied Europe were run directly by the Germans, Chomiak’s paper was not, suggesting a degree of trust and collegiality between the paper’s editorial staff and Nazi authorities. Indeed, Ukrainian Canadian researcher Alex Boykowich unearthed a photo from the province of Alberta archives of Chomiak at a social gathering with Emil Gassner, who was in charge of the Nazis’ press department and answered directly to Joseph Goebbels, in addition to other documents revealing the extent of Chomiak’s collaboration.

As Himka notes, Gassner directly instructed the paper’s editors to print a series of antisemitic articles in the spring of 1943, just as the Warsaw Ghetto uprising was underway, which the *Krakivski Visti*’s editorial staff surmised as an opportunity to demonstrate their fealty to the Germans. Headlines from that time include ‘At the Sources of the Universal Conspiracy,’ ‘A Nation of Desperados,’ ‘The Jews Are Depraving Europe,’ and ‘How They Helped the Bolsheviks.’ One article said the Jews ‘always take the side of our enemies.’

Freeland could have simply and honestly acknowledged this disturbing aspect of her grandfather’s legacy and moved on—plenty of contemporary German officials with troubled family histories are perfectly capable of doing so—but instead she has used it as an opportunity to sow fear and mistrust about foreign threats to Canadian democracy.<sup>287</sup> [My emphasis.]

The lack of denouncement of Nazi ideology three generations hence by Freeland is not an oversight. The signal of such ingrained ideology came on the cusp of rolling out new warfare tactics onto the common people.

In February 2022, the Canadian government cracked down on a Ottawa-bound trucker convoy that did not cede their personal liberties regarding vaccines mandates and transportation passports to move across the US-Canadian border (the longest unencumbered border in the world). With Freeland as its finance minister, Canada engaged in financial warfare against their people by de-banking them, closing their corporate accounts, suspending their insurance policies, and then, labeling these protesters as being a part of a “fringe minority.”<sup>288</sup> Prime Minister Justin Trudeau stating that trucker convoy are “holding unacceptable views...do not represent the views of Canadians...who know that ‘following the science’ and stepping up to protect each other is the best way to continue to ensure our freedoms, our rights, our values as a country.”<sup>289</sup>

Meanwhile, that same month, Canada offered \$7.8 million in military aid and \$500 million loan to Ukraine for its defense efforts.<sup>290</sup> Chief defenders of Ukraine are the Azov Battalion, a pro-Nazi, paramilitary-political outfit

supported by US, UK and Canadian politicians against Russia for the last decade.<sup>291,292</sup> During this time, an estimated 6,500 Russians were killed by Ukrainian forces in the Russian-speaking oblasts of Eastern Ukraine. But death estimations are broad across both warring elements in UN reports.<sup>293</sup>

Then MP Chrystia Freeland in May 2015 wrote for the *Brookings Institute*, “My Ukraine: personal reflection on a nation’s dream of independence and the nightmare Vladimir Putin has visited upon it.” In her reflection, she noted her recent ban from Russia. Then, she delved deeply into her views on Russia - colored well by U.S. neoconservatives listed alongside her on the Russia ban list like U.S. Senator John McCain.

This Russia ban is easily linked to the Magnitsky Act signed into law in December 2012 by President Obama, co-sponsored by McCain, as *Epoch Times* wrote, “The Act barred Russian officials suspected of human rights abuses from entering the United States, allowed for their U.S. assets to be frozen, and prohibited financial transactions with U.S. financial firms.”<sup>294</sup> [My emphasis.]

This 2012 law germinated from Sergei Magnitsky’s death in 2009, a Russian who exposed fraud and corruption inside the Russian government. His death, according to Bill Browder, his boss and CEO at Hermitage Capital Management, occurred shortly after a \$230 million tax rebate was heisted off the Russian government through Universal Savings Bank, that was then quickly liquidated. Sergei was accused of participating in the heist, but Browder, who was friendly with Putin for many years prior to this, suggested Sergei was framed for this crime.<sup>295</sup> Sergei’s unfortunate detention in Russia resulted in nearly a year of abuses, real and sustained enough, that his death in November 2009 reflected classic torture and terrorizing treatment that he could no longer endure.<sup>296</sup>

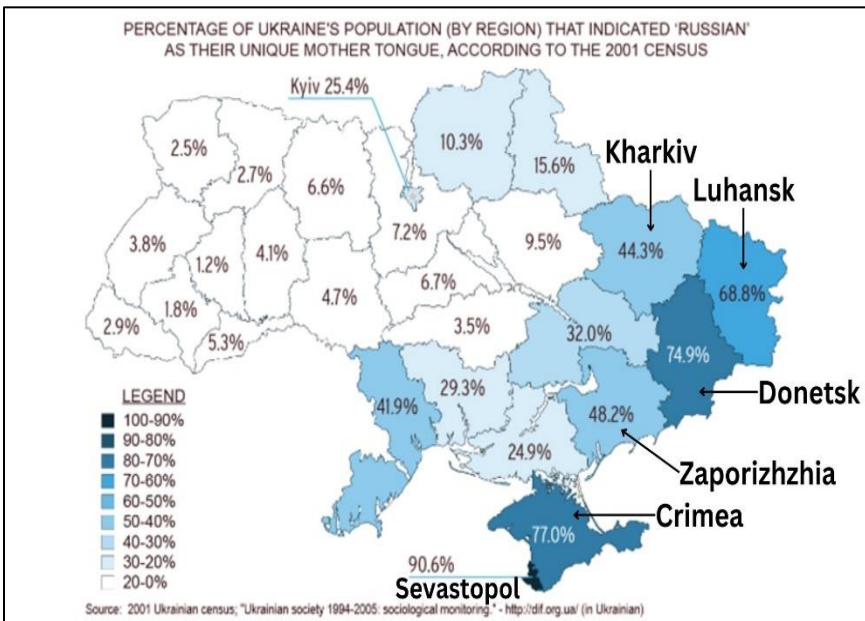
While the Magnitsky Act is well-intentioned, such “human rights”<sup>297</sup> abuses are not a significant barrier with respect to the well-known Uighur abuses in China; or China’s poor treatment of factory workers, needing suicide nets at Apple-connected, Foxconn plants.<sup>298</sup> (This Foxconn story has been sanitized. Author Jenny Chan wrote, “A Suicide Survivor: the life of a Chinese migrant worker at Foxconn.”<sup>299</sup> The paper was removed, but one can find it at the endnote cited.<sup>300</sup>) On display here may be the legalese that captures Russia’s tie-in by international law to various international organizations, including European Convention on Human Rights.<sup>301</sup>

Again, while seemingly admirable on its face, the U.S. government has inconsistently applied its own values, especially since 9/11, regarding unlawful its behaviors. (Drone strikes on a U.S. citizen (and minor, Abdulrahman al-Awlaki) through Obama’s “kill list” orders.<sup>302, 303</sup>)

But back to Freeland’s story. She wrote of her connections to the Kremlin’s WEF and hobnobbing with top, second Russian banana, Dmitry Medvedev<sup>304</sup>:

“Until March of last year, none of this prevented my getting a Russian visa. I was, on several occasions, invited to moderate panels at the St. Petersburg International Economic Forum, the Kremlin’s version of the World Economic Forum in Davos. Then, in 2013, Medvedev agreed to let me interview him in an off-the-record briefing for media leaders at the real Davos annual meeting.

That turned out to be the last year when Russia, despite its leadership’s increasingly despotic and xenophobic tendencies, was still, along with the major Western democracies and Japan, a member in good standing of the G-8. Russia in those days was also part of the elite global group Goldman Sachs had dubbed the BRICs – the acronym stands for Brazil, Russia, India, and China – the emerging market powerhouses that were expected to drive the world economy forward.”<sup>305</sup>

Later, in her history-trekking piece, Freeland brings up a visit with Ukrainian President Petro Poroshenko, a partner-in-crime of then VP Joe Biden, citing Petro’s tweet and the idea of freedom based in Ukraine:

“President Petro Poroshenko celebrated the formation of a new government following October parliamentary elections with a tweet that made this point to his 237,700 followers: ‘The main difference between Ukraine and Russia isn’t only linguistic, it lies in our differing political cultures and attitudes to freedom and democracy.’

It is an entirely good thing that Ukraine's new leaders are defining their national identity as inherently democratic and freedom-loving. But there have been times when Russia might have laid claim to such an identity, too.”<sup>307</sup> [My emphasis.]

The next President, WEF-backed Volodymyr Zelenskyy, suspended democracy. Since the start of the 2022 war, he passed authoritarian edicts removing Russian-named places and requiring Ukrainian language proficiency and history to obtain citizenship.<sup>308,309</sup>

Just a month after Freeland’s meeting with Poroshenko, Hunter Biden wrote a voluminous outline on Ukraine’s future to Devon Archer, his sidekick on the board of Ukraine’s Burisma.<sup>310</sup> This email is not standard Hunter Biden thinking. Rather, it is well-crafted, thought-out like a U.S. State Department analyst. Hunter Biden sent the following in April 2014:

“1. Poroshenko appears to be the likely next President. Determining our teams relationship with him is important. He is credible with the west and by all accounts a true reformer (by Uk [Ukraine] standards).

2. Some sort of decentralization will likely occur in the East. If it doesn't the Russians will continue to escalate there destabilization campaign, which could lead to a full-scale takeover of the eastern region most critically Donetsk. The strategic value is to create a land bridge for RU to Crimea.

3. That won't directly affect Burisma holdings but it will limit future Uk exploration and utilization of offshore opportunities in particular.

4. It will also result in further destabilization of Uk nationally and for whatever govt is in power. And the US will respond with even stronger sanctions. Those sanctions will threaten the tenuous support of the EU which does not have the political will to incur steep energy price increases.

5. Which will result in further price increases on RU gas to the Uk.

6. The IMF loan guarantees will allow the Uks to weather the economic impact, but the required reforms to Uk public subsidies will weaken the new President.

7. There will be enormous pressure on Burisma to lower prices for the national good. Even if the company takes a hit in profits it would seem imprudent to raise prices in convert with RU price gouging.

8. Burisma has an opportunity here to play the hero if it ignores the artificial market value of their product and plays to the national interest.

...

This could be the break we have been waiting for if they really are smart enough to understand our long-term value. If they are looking to just use us until the storm passes then we risked far too much for far too little. We could be invaluable in expanding their operations outside Uk [Ukraine] by promoting their US partnerships and expertise - whether that's China, Mexico, other parts of the Black Sea, Poland, etc."<sup>311</sup>

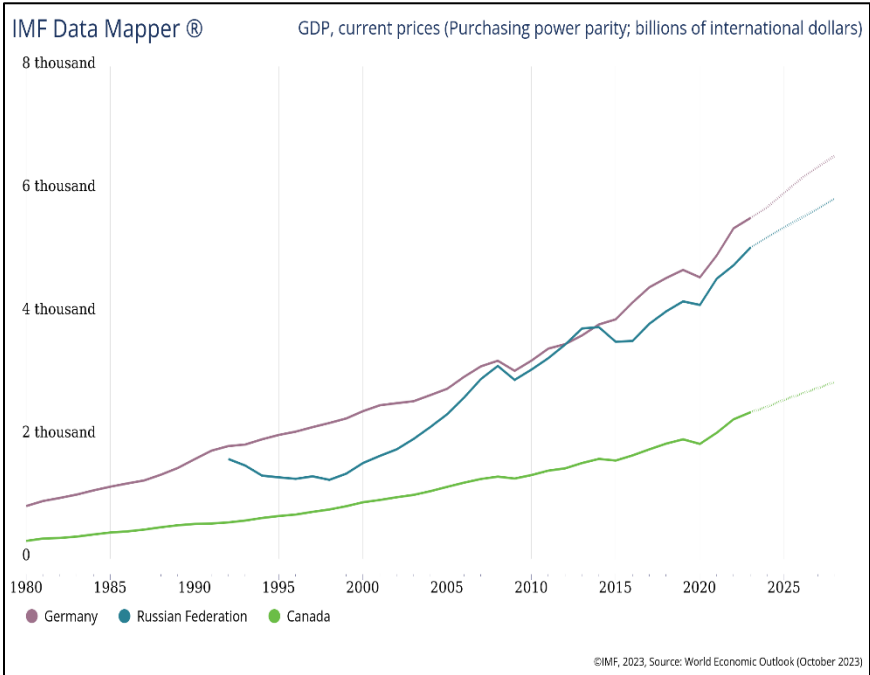
*Then Canadian MP Freeland met with Poroshenko, the US puppet.<sup>312</sup>*

Freeland is a WEF officer, sitting on the board of trustees.<sup>313,314</sup> She wrote *Sale of the Century: The Inside Story of the Second Russian Revolution (2000)* while based in Moscow for the *Financial Times*. She then delved into the post-Soviet economy and its benefactors not being among the common people.<sup>315</sup>

Such Russian economics have rapidly changed under Putin's regime through the BRICS+ since 2014. After Ukraine's Maidan Revolution, Russia's



economy is increasingly interlinking to Chinese fortunes, doubling overall trade exports from 2018-2023 to over \$200 billion.<sup>316</sup> India too has expanded its subtle support for Russia (through oil processing) as the Russian-Ukraine 2022 war raged and Nord stream pipeline sabotage occurred.<sup>317</sup> Overall, Russia, now matches (and likely exceeds, despite the IMF's numbers) Germany's GDP (Purchasing Power Parity) going into 2024.<sup>318</sup> This as Germany wrecks its own legendary industrial might with hair-brained 'green' policies pushed by their climate change radicals.

Freeland's boss, Trudeau (is he the love child of Fidel Castro?)<sup>320</sup> reflects the yin-yang of Fascism and Marxism molded just north of the U.S. border. Given both their pronouncements on freedoms and health, this framework seems hardwired into their genetic makeups.<sup>321</sup> Just follow their behaviors.

Sabotage and guerrilla warfare tactics are well-known. These are becoming readily apparent as phase of restricting resources and continued interruption of supply chains. Such is occurring by proxy and through covert operations around the globe. On February 8, 2023, Pulitzer-Prize winning Seymour Hersh published, "How America Took Out the Nord Stream Pipeline," on his Substack. Hersh stated that:

"Last June, the Navy divers, operating under the cover of a widely publicized mid-summer NATO exercise known as BALTOPS 22, planted the

remotely triggered explosives that, three months later, destroyed three of the four Nord Stream pipelines, according to a source with direct knowledge of the operational planning.

Two of the pipelines, which were known collectively as Nord Stream 1, had been providing Germany and much of Western Europe with cheap Russian natural gas for more than a decade. A second pair of pipelines, called Nord Stream 2, had been built but were not yet operational. Now, with Russian troops massing on the Ukrainian border and the bloodiest war in Europe since 1945 looming, President Joseph Biden saw the pipelines as a vehicle for Vladimir Putin to weaponize natural gas for his political and territorial ambitions.”<sup>322</sup>

As if the bloody Ukrainian battlefield was not enough, on October 7, 2023, Israel-Hamas conflict kicked off with the surprise attack made by Hamas at the cusp of the 50<sup>th</sup> anniversary of the 1973 Yom Kippur War. Thereafter, Israel Defense Forces responded *Old Testament* style.<sup>323</sup> Protests worldwide were triggered; with a decided anti-Israel bent notable, given the initiator of these soft target, brutal attacks was Hamas leadership. This attack claimed over 1,000 Israelis. (Palestinians deaths may reach 100-fold that total or more.)

Questions arose regarding intel failures by Mossad (Israel’s CIA) and poor response times to this highly-coordinated (both land and air), well-executed military operation by Hamas and their now accomplices in such terroristic acts: Iran. Since that moment, Hamas has refused to return Israeli hostages without concessions that Israel will never agree too. Israeli PM Benjamin Netanyahu went full scorched earth in the *Holy Land*. That decision may ultimately result in a devastating erasure of all Palestinians, and likewise: any lasting Israeli claims to moral authority.

As with all rising military engagements, there are those that have foreknowledge to profit handsomely. Two professors noted financial market activity suggestive of insights had prior to this heinous attack.<sup>324</sup>

“A new paper by Robert Jackson Jr, a former commissioner of America’s Securities and Exchange Commission, and Joshua Mitts of Columbia University suggests so...

The authors’ most striking finding is a surge in short sales—bets that a security’s price will fall—of an exchange-traded fund (ETF) listed on the New York Stock Exchange under the ticker *EIS*, which tracks an index of Israeli shares. In September an average of 1,581 shares a day of *EIS* were sold short, representing 17% of the daily total trading volume. On October 2nd, five days before the attacks, a whopping 227,820 shares were shorted, representing 99% of total volume.

...During the three weeks before the attacks, the number of outstanding options contracts expiring on October 13th on American-traded shares of

Israeli firms—the derivatives that would yield the greatest returns if prices moved sharply in the direction a trader expected, and expire worthless otherwise—rose eightfold.”<sup>325</sup>

By December 2023, with Middle East chaos rising, Red Sea trade was impacted. A trickle of problems grew to over 100 transport ships diverted. The WEF’s omens of geopolitical tensions appeared as envisioned.

The Houthi rebels (Iranian-backed, China-approved) hit major shipping operators with missiles from their drones. China’s COSCO suspended its transports through the Red Sea in early January 2024. The countering result: diverted traffic navigated down and around the Cape of Good Hope, adding many days of travel.<sup>326</sup> The Houthi operations achieved a first, in early March 2024, sinking the bulk carrier *Rubymar*.<sup>327</sup>

U.S. and NATO-aligned countries spoke of a coalition ship escort (*Operation Prosperity Guardian*) and fighting force, but this alliance collapsed quickly. The Biden administration rotated two Carrier battle groups into the region (the Gerald R. Ford and Dwight D. Eisenhower) to backstop security around Israel. The Ford group was already on extended operations, and trekked back to its home port in January 2024.

The Red Sea/Suez Canal impacts up to 12% of global trade. But such is more complex when looking at the types of goods going through and similar issues (due to a drought in Panama) with the other well-known canal:

“...30% of all global shipping container traffic uses the stretch of water, which is a huge amount when you consider what that means in terms of a global view.

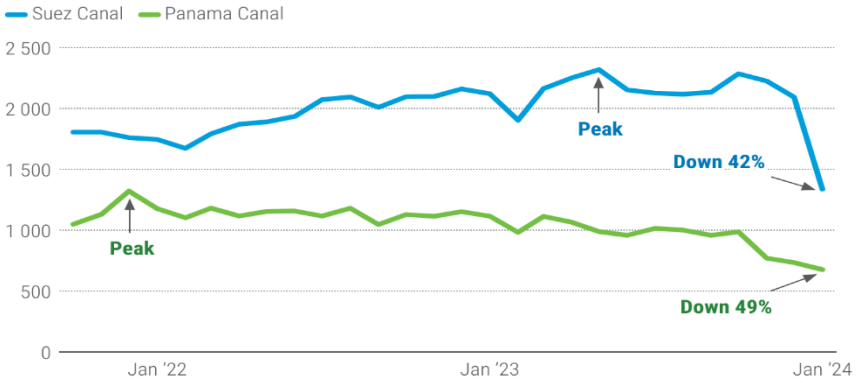
When broken down into types of activity, it’s also interesting to see how the Suez assists different sectors. For example, 7-10% of the world’s oil supply is transferred via the stretch of water, which is a significant amount. As you can imagine, this high amount of global shopping means big money for the Suez Canal Authority, which saw revenues reach more than \$9 billion in 2023.”<sup>328</sup>

The U.S./Europe’s economic and political frameworks are disintegrating from within and with international, counter pressures coming out of the BRICS+. Other hot spots (Venezuela-Guyana<sup>329</sup>) cropped up due to these weakened relationships and geopolitical transformations occurring across the world. Poland, after reinstalling PM Donald Tusk, took over their public broadcast networks in a move reminiscent of the old Soviet Union.<sup>330,331</sup> Biden’s stewardship invited authoritarian upticks and the rise in domestic and foreign tensions. Nation-states noticed a corrupt octogenarian without a coherent thought and have taken advantage of this weakness without ado. This war operates to decouple (or disintegrate) the world order into totalitarian control, starting with information, and ending in AI-genetics.

Number of monthly transits in Suez and Panama Canals, October 2021–January 2024

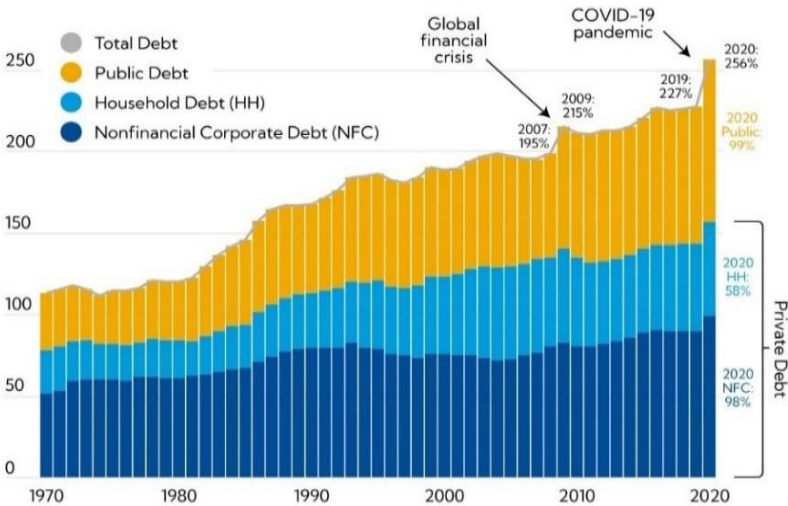

## Historic highs

Inflationary pressures are present again akin to the decade of the 1970s. World leaders sat idle as consumer prices went up across the West. The monetary policy shifted, printing (electronically) trillions of dollars in stimulus in lockstep with implementing the March 2020 lockdowns. This shrunk employment throughout the world and stymied supply chains. Such policies fueled billionaire wealth, furthered control, and required radical narratives to preoccupy the commoners away from *The Great Reset*.

These initial inflationary impacts were only delayed, not denied - as it takes 9-18 months for such monetary policy to wind its way through a global financial system. From mid-2021 through 2023, consumer prices were much higher for most food and consumer goods. Asset prices rose, but will fall precipitously once the sugar high of stimulus evaporates away.

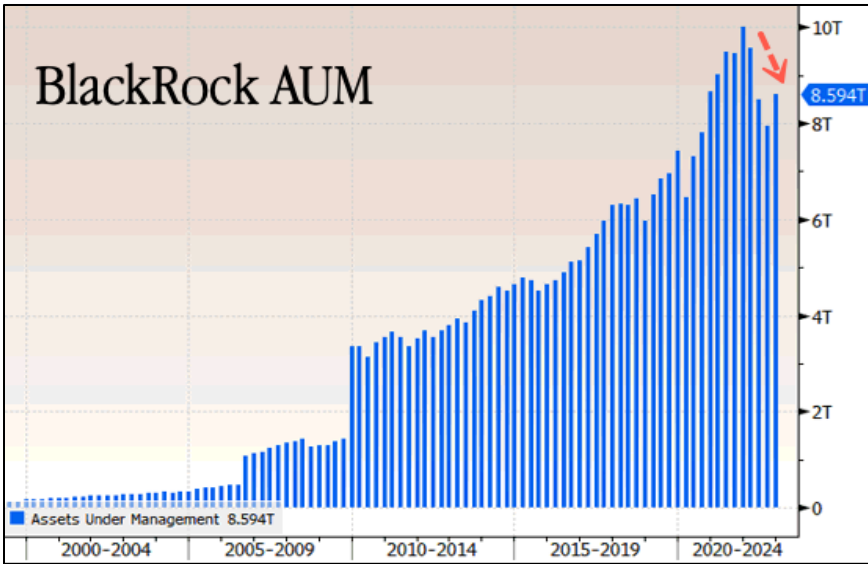
From 2024 onward, there is serious potential for asset deflation across the West. This will impact ordinary consumers the most as they have spent through their savings (and stimulus), while the most well-off have ample liquidity to buy up distressed assets under such a deflationary scenario.

The COVID-19 protocols, as many predicted, only enhanced the common man's misery. Ensuring long-term destabilization of economies with pre-existing structural issues already fomented by a decade of zero-interest policies (ZIRP) and gutted manufacturing sectors while courting and catering to climate change obsessions.

Chief among the guilty parties was the United States, its Fed Reserve and congressional leadership. To spend trillions on welfare programs, wage war for two decades, and gut manufacturing, defiled the idea of a balanced budget and sane domestic policy. The U.S. national debt from 2019 to 2023 rose by \$10 trillion, surpassing \$34 trillion at the dawn of 2024.<sup>333</sup> The Global Debt blew well past \$300 trillion with OTC and shadow financial derivatives well beyond the *quadrillion dollar* range, but these, when reported, are logged as much less, or just ignored completely.<sup>334, 335, 336</sup>

As William Shirer discussed sixty years ago, regarding debt, taxes and inflation, benefits only the most powerful people and companies. Chief among them, a key benefactor of March 2020 stimulus: BlackRock. BlackRock secured access to Federal Reserve fiat money with \$454 Billion coming directly out of the 2020 CARES Act.<sup>337</sup>

Larry Fink, a known ally of Klaus Schwab and Bill Gates, has over the course of the last decade, amassed \$10 trillion in assets under management at BlackRock. Fink, the financial version of Harari, desires "forcing behaviors" from his *Deal Book* interviews with Andrew Ross Sorkin of *CNBC*.<sup>338</sup> Another cousin company, Blackstone, bought up residential and commercial real estate off the fiat generous FED policy put in place. All the usual billionaires saw increased largesse out of the FED printing money for them, while wiping out the middle class without any remorse.



To blame shift off these subtle leverage buyout tactics, the powers that be furthered narratives about *White* extremism. The socialist-minded billionaire-class engage heavily in pay-to-play schemes since *Citizen United* on a scale that made prior incarnations of lobbyist-backed cronyism seem almost pedestrian. As such, these globalists closely invest in government policy and their strongest agencies like the Department of Justice. With other United States agencies keenly incited (and surveilling) the U.S. population to find such extremism, that of course, one could say these government agencies are responsible for causing through psychological and economic duress. Testimony in May 2023, by FBI whistleblowers, confirmed that has been the FBI's agenda, in particular regarding J6, with infiltration and inciting up rightly disgruntled Americans.<sup>339</sup>

In the early 2010s, off the well-known financial corruption regarding the *Great Recession*, there was a “cynical bargain”, according to Vivek Ramaswamy to shift narratives to racism, for instance, in the United States when *Tea Party* and *Occupy Wall Street* movements formed from the right and left. Those movements were infiltrated; even as these movements were rightly upset at the Globalist money class over destructing their financial lives, with derivatives and billion-dollar crimes and hustles. Millions of working-class folks were left to pay for the ills of the unaccountable Wall Street and the U.S. Federal “governance” class.

The Clinton, Bush and Obama administrations all were to various degrees determinative of what happened through the decline of the middle class, no matter their races or creeds. The exportation of jobs, the gutting of manufacturing, the rise of behemoth financial entities, and the irresponsible choices these administrations made regarding OTC derivatives, housing, wars, manufacturing, and debt servicing, made for a

*master class*: how-to steal from the very people that feed the country, through farming, and their intellectual capacity, for innovation, while government wasted their taxes on Middle East wars, Technocrats and Socialist Giveaways to buy up enough voters to *maintain their power*.

As Shirer noted, tellingly, about such government failures: “What good were standards and practices of such a society, which encouraged savings and investment and solemnly promised a safe return from them and then defaulted? Was this not a fraud on the people (Shirer, 57)?”<sup>340</sup>

Shirer’s take would run at odds with the Biden administration’s FHFA mortgage policy that punished those with higher creditworthiness with higher mortgage payments to subsidize higher-risk borrowers.<sup>341</sup> Thirty-four state financial officials sent a letter opposing this naked “equity” policy that disincentivizes good financial behavior while burdening what is left of the American middle class.<sup>342</sup>

Biden’s SEC was poised to use a “Natural Asset Company” scheme to seize up land and resources across the country. These tracts of land, water, and their underground resources are to be placed in a “conservation state.” But then, easily enough seized and sold (through eminent domain laws) to foreign entities, who will proceed to rape the ground Americans split blood and toiled to maintain since before the 1776 Revolution. But this is acceptable as long as the people are told they are “white extremists” to fret over, and the government knows what is best for you.

From the NYSE pitch paper regarding the Natural Asset Company necessity:

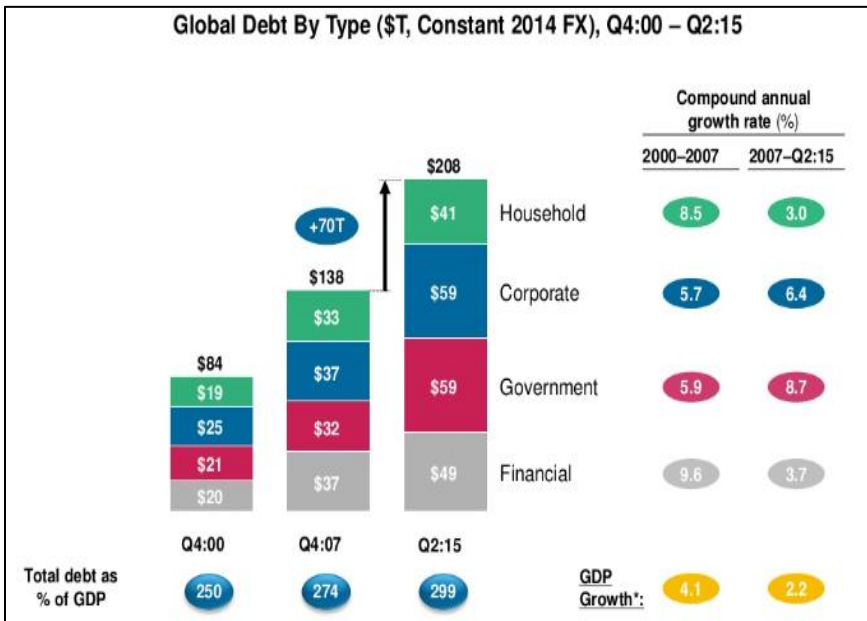
“Recognizing the urgency and opportunity presented by these conditions, investors increasingly express a desire for investment vehicles that will permit them to express a sustainability thesis. Improvements in corporate disclosures, introduction of climate and nature-focused indices, and the development of ESG funds screening for preferred or prohibited factors have all expanded the accessibility of sustainable investing. Despite these advances, however, investors still express an unmet need for efficient, pure-play exposure to nature and climate.”<sup>343</sup> [My emphasis.]

One’s instant opinion on the Natural Asset Company scheme: Biden, the FED, and Congress as well are attempting to keep the Ponzi scheme going long enough so they will not garner the final blame when people find out they are indentured slaves forever and no longer have a chance to succeed in the vestiges of the United States.

“A long train of abuses” got us to this point. A few state secretaries of Treasuries and private citizens have sent their critical comments to the SEC regarding this ESG-BlackRock-NYSE stock exchange Ponzi scheme to divvy up U.S. Assets based off the environmentalism hustle.<sup>344,345</sup>

As well, these corrupting forces were not isolated to just the United States. In Canada, and across the globe, governments threatened and harassed their populations over the 2020 ‘enhanced’ flu virus, demonized their thoughts and verbal suggestions for years,<sup>346</sup> and refused to listen about the pervasive, media insanity of locking down healthy people with the immuno-compromised. This occurred in a coordinated destructing of economic lives of tens of millions of small businesses worldwide at the now visible hands of *World Economic Forum Partners (WEF)*, the *World Health Organization (WHO)*, and China’s promoted lockdowns.

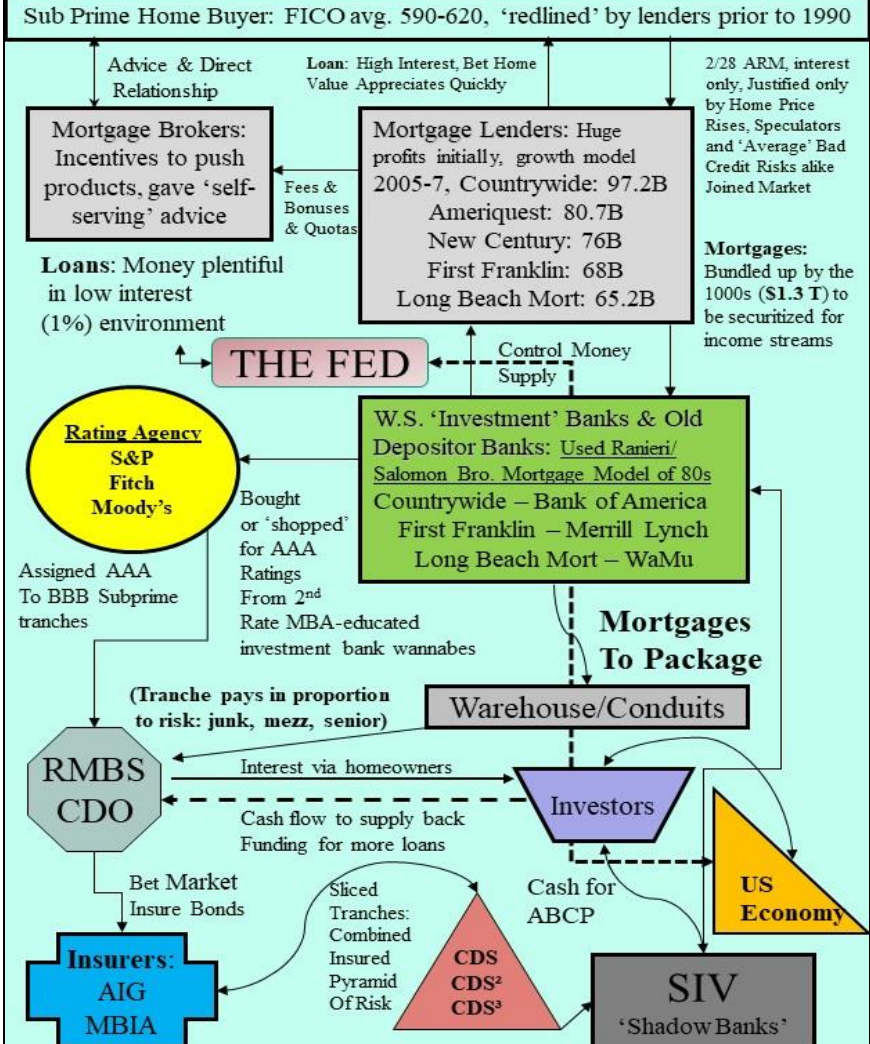
China’s lockdown strategy was mimicked (or intentionally copied) to destabilize Western economies (as world debt levels skyrocketed\*) to usher in Klaus’s infamously *Great Reset*.<sup>347</sup> A myriad of political figures parroted this propaganda line routinely, and continue so in the present, especially when useful as a negative reinforcement (or punishment) for those that do not adhere to its illogic; or irrationality, in light of the “COVID crisis.”



[\*Getting an accurate account (see above) of World Debt depends on which organization provided the numbers, when they provide them, and whether they are measuring the same basket of countries entities and/or persons correctly in *one snapshot*. One has found that World Debt is probably well past \$325 trillion (US) and growing as of this early 2024 writing. Any changing of the world reserve currency undoubtedly makes this number a different ballgame in the future. Collapse allows for the *next global Ponzi-Madoff scheme* until that one collapses as well. All currencies fail due to the propensity of the governments and alliances to make war, make economic promises to stay in power, while being grossly irresponsible.]

A 'simplified version' of the GFC. (ABCP) Asset-Backed Commercial Paper tied to (SIV) Special Investment Vehicles (attached to Shadow Banks).

Further psychological deflection tactics were used by WEF-aligned governments. When common people expressed their concerns about corruption, equal justice under the law, allowance of sects to operate with legal impunity (in rioting, illegal migration flows) and the grooming of minors, but labeling this "social justice", it reflected a purposeful, ideological schism brought on by class warfare. The billionaires and aligned well with nearly all present-day governments. The governmental agencies

(The Worldwide BLOB) are populated with persons that show markers of achieving *Class Consciousness*: a blatant disregard for the common people because the bureaucrat is no longer connected with their citizenry; see themselves above the population; and holds a separate set of beliefs and desires altogether from the people they are meant to serve.

An attendee at the 2022 World Economic Forum Davos meeting, stated that: “the elite across the world trusted each other more and more...The bad news: in every single country they were polling, the majority of the people trusted their elite less.”<sup>348</sup>

The WEF receives many political dignitaries at its public-private-partnership (PPP) meet ups. These meetings are routinely attended by U.S. intel personnel such as DNI Avril Haines and FBI director Christopher Wray.<sup>349,350</sup> U.S. Indiana governor Eric Holcomb personally attended the WEF 2022 Davos meeting, speaking before Klaus Schwab’s cronies.<sup>351</sup>

Echoes of class issues and conflicts operated during the short-lived Weimar Republic, post-World War I, as Shirer expressed:

“Under General Hans von Seeckt, the brilliant creator of the 100,000-man Reichswehr, the Army, small as it was in numbers, became a state within a state, exerting an increasing influence on the nation’s foreign and domestic policies until a point was reached where the Republic’s continued existence depended on the will of the officer corps (60).”<sup>352</sup> [My emphasis.]

*The Federal Administrative State*, numbering 2.9 million plus<sup>353</sup>, is skewed 90% plus towards one political party in concert with social media and technology companies donations to the DNC.<sup>354,355,356</sup> Including the *State Administration* rolls, and this totals exceeds 24 million combined.<sup>357, 358</sup>

In 2022, Congress passed a contentious bill to add 86,852 IRS Agents.<sup>359</sup> The IRS promoted in their job descriptions the usage of guns (gun training) for enforcement. Thereafter, a weak new Republic Congress attempted to defund this “refurbishing” of the IRS.<sup>360</sup> One cannot fail to notice the goals of various State-Federal politicians and their laws passed to disarm the population while they sneakily arm up various agencies for battle.<sup>361</sup>

[This as FBI crime statistics, since 2001, showed a decline in violent crimes.<sup>362</sup> But, in 2020, after three more years of such declines, the COVID-Floyd combination re-escalated crime. Early release, no cash bail, and “defund the police” impacted as well. These policies were pushed by radical Congressional representatives, labeled: Social Justice Democrats. Democrat-controlled cities suffered the most, as crime up-ticked (if the reporting of it did not) despite the propaganda spin of the media. (The FBI is not comprehensive in their crime data, requiring data collection at the metro and county levels. FBI’s data gathering changed in 2021 just as Biden’s administration came in.<sup>363</sup> Volume III will explore this further.)]

This current battle of *class ideologies* - that of nation-state integrity, control of its borders, culture, economy and constitutions versus no borders, mass migration, mass censorship by unelected federal bureaucracies, and mass surveillance - is extraordinary, pitting post-WW2 nationalism versus an extremist sect: the 21<sup>st</sup> century globalist mindset. The latter is being installed, like a virus, by U.S. Agencies through the octogenarian-in-chief Biden's executive orders and the unbridled spending of the U.S. Congress. A financial day of reckoning is coming very soon.

Thus, the 21<sup>st</sup> century hallmarks of fascism arise out of a leftist (Democrat) worldview: collectivism and censorship guised behind so-called empathetic natures regarding the planet, but are done merely in the service of federal agencies from the FBI, the CIA, to the CDC and NIH, and this alphabet list could include hundreds of U.S. agencies. These congealed forces are abetted by a Neocon-controlled irrational foreign policy that D.C. Democrats applaud, and profit off of in the many millions, if not billions.<sup>364</sup>

The rise of the next dictator(s) is not in the future, as they are present now. Those forces are being made from the congealing of the factors of inflation, ongoing war and future conflicts, massive social changes, and the seizure of power by international bodies. This last one, pivots on the *WHO Pandemic Treaty* which, as designed, will further subjugate nation-states to the whims of autocratic health officers and their declarations of emergencies.<sup>365</sup> The prime ministers and presidents of countries *are demoted in decision-making* while closely adhering to the formalized ideas of control of an international body that is at the whims of China's one-party rule and their like-minded billionaire-on-health: Bill Gates.

Thus, when Klaus mentioned penetrating cabinets, such can be seen as a chess maneuver: to control or influence greatly both the international bodies and the nation-state agency heads through slick indoctrination; and by early selection of those most amendable to these practices, a two-pronged pincer move has been achieved. That of a firm grasp on Global and Nation-state top technocrats that read from the *Transhuman Bible*.

Unlike his Nazi-forming progenitor, Klaus amped up *the fear of future Earth catastrophes* propaganda versus the one trick pony, race-based propaganda of Hitler. Klaus developed a closed-silo selection process for young, talented and easily corrupted minds. The Young Global Leaders mirrors the *Who's Who* in industry catalogs of bygone years. While Hitler's ragtag group congealed through the Weimar chaos and their later propagandist activities brought in extremists from all walks of life, particularly army veterans who felt rightly or wrongly: "stabbed in the back (Shirer, 31)."<sup>366</sup> The Nazis cultivated well a host of sociopaths, from all walks of life, including schoolteachers, that were later called, "sadists," "homosexuals," and "perverts (50)."<sup>367</sup>

Biden's administration (and Klaus is friendly with Biden personally), hired a transgendered man for a top HHS position; a crossdresser, assigned to nuclear security, who later stole luggage at the airport, and was fired thereafter.<sup>368</sup> Biden's executive orders emboldened a transgender movement, while diminishing and demonizing half the population: calling them MAGA Republicans or MAGA extremists.<sup>369</sup>

If anyone in the United States dared to question their schools' policies,<sup>370</sup> in promoting radical LGBTQ towards minors, as early as pre-middle school, they were labeled "domestic extremists" or "terrorists."<sup>371</sup> These smears coincided with a rape *by a minor*, who later claimed himself as transgendered, that was covered up by a Loudoun County, Northern Virginia school system, home to many federal officials.<sup>372</sup>

On March 27, 2023, a transgender male attacked a Nashville, Tennessee Christian school, killing six, including three children.<sup>373</sup> Motive may lay in a long-ago sex crime, not prosecuted. As of this writing, the FBI has not released the entire manifesto that accompanied this heinous individual action. In past cases, such scribblings are released if it promotes a certain narrative.

(Note: It is not the gun that does this. It's the psychological destruction by a medical community promoting changes as affirming and curative of gender dysphoria, in this particular case. Such medical malpractice echoed the Nazi regime's psychiatric maleficence that emboldened the Malthusian and racial purists.<sup>374</sup> By never addressing the underlying issues: criminal abuses, and the inability to process one's emotions, expresses destructively in many instances. Shamefully, these procedures are exploited as a market for profit<sup>375</sup> and used as a country-fracturing agenda targeting minors.<sup>376</sup>)

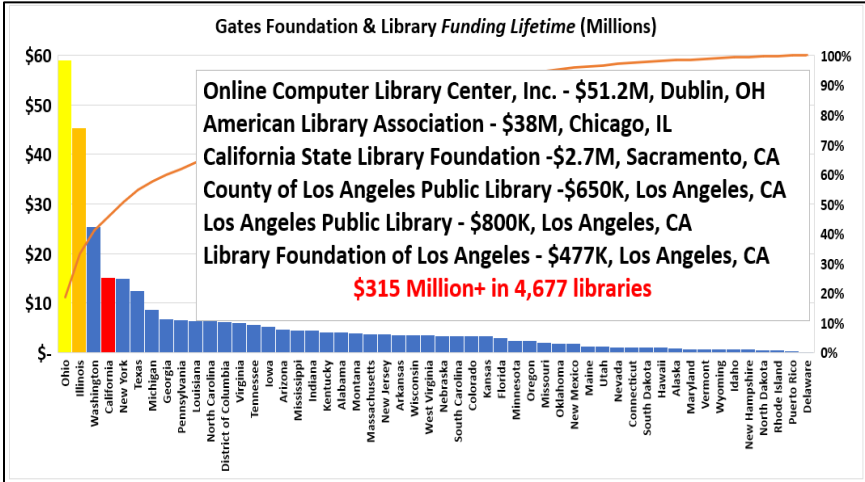
The school systems are fraught with LGBTQ erotica. A generation or two ago, these books would have triggered arrests of the peddlers of such pornographic trash. Now, librarians reign supreme while the parent is made toothless - and *The State* has decided anything shall go - if they can get any alleged "affirmative consent" from a confused, propagandized child.

Teachers and administrators encourage minor children to hide information from their parents - their mothers and fathers who feed, cloth, house and love their children - are to be inferior in the decisions of their children: the ones they brought into this world out of actual love.<sup>377</sup> Gender reassignment surgeries *among minors* are rising<sup>378,379</sup> as doctors have divested themselves from their ethical phrase: "first, do no harm."

The WHO has promoted Marxist ideology for many years - as it deems minors are able to consent to vaccinations and encourages rebellion against their parents. Such promotion paralleled the Hitler's youth movement or Mao's cultural revolution. Shirer noted this occurred in Germany (249):

“The German schools, from first grade through the universities, were quickly Nazified. Textbooks were hastily rewritten, curricula were changed, Mein Kampf was made - in the words of Der Deutsche Erzieher, official organ of the educators - “our infallible pedagogical guiding star” and teachers who failed to see the light were cast out.”<sup>380</sup>

One of the more pernicious echoes here came at the hands of Klaus’s chief partnership on the WEF website: *The Bill & Melinda Gates Foundation*. This NGO bought its way into libraries and scholastic endeavors<sup>381</sup>; and specifically, under the Obama administration, promoted “Common Core.”



Even a leftist media/intelligence organ, *The Washington Post*, published negative stories about Gates’s involvement in your child’s education, noting that, “Critics go further, charging that some of their projects have harmed public schools because they were unworkable from the start and consumed resources that could have been better spent.”<sup>382,383</sup>

A child, with incomplete mental capacity, that can be psychologically twisted to hate their parents and snitch on them as well for any disciplining in respect to their unapproved choices, will be weaponized to get The State involved. (This does not mean parental abuse is to be ignored. But evidence is required, not accusations, that are sought now by teachers that act like East German *Stasi* recruiters.<sup>384</sup>) *The Daily Mail* reported on June 19, 2023: “Some teachers...discussed being 'subversive,' how their personal 'code of ethics' trumped laws, and how to 'hide' a trans student's new name and gender from their parents.”<sup>385</sup>

From that point forward, the easily manipulated child will thoughtlessly carry out any messaging (as a cult follower, a Stockholm Syndrome sufferer) to achieve acceptance from its new master: a state official who takes glee in their new-found control and state funding that comes from garnering such (unelected and undeserved) amassed powers.

Lastly, among Klaus's most revealing moments, out of his mouth, was this:

"I give you one example which for me was probably a crucial moment in my life. I traveled for the first time to Brazil, I met a priest who was known at that time as the priest of the poor people. His name was Dom Helder Câmara."<sup>386</sup>

Carson McAuley's multi-part series on Klaus reflected that, regarding Câmara and Klaus, they were instantly simpatico based off an ideology that has produced most of the greatest misery worldwide:

"What we do know, however, is that Câmara, a bishop slight in stature but of immense reputation and presence, showed Schwab around his diocese of Recife, an infamously impoverished shantytown in the north-east of the country. So affected was Schwab by what he claims to have witnessed there, that he was compelled to invite the little clergyman to speak at his convention in Davos. His business associates were less enthused - Câmara was a card-carrying communist, after all. Yet so heavily did the memory of Recife weigh on the conscience of Schwab (as he takes pains to emphasize) that he pushed on regardless, the archbishop's inclusion so controversial that, for a time, it threatened to jeopardize the still fledgling WEF project."<sup>387</sup>

...You see, while still in his mid-twenties, Father Câmara, as he was known at the time, was rapidly rising in the ranks of a clerical far-right movement known as Acao Integralista Brasileira (AIB), later establishing himself on the group's Supreme Council, as well as in the role of personal secretary to their founder. The organization's resemblance to European fascist counterparts was not only stark, but intentional. Modelling themselves on Mussolini's Blackshirts, the AIB boasted their own paramilitary faction, the youthful Câmara so dedicated to their cause that he is said to have worn their distinctive green uniform under his cassock during his ordination."<sup>388</sup> [My emphasis.]

In essence, there is an intentional replay of pre-WW2 activities, regarding health, perversion, propaganda, and class struggle. Klaus's perpetrating players reused a Rockefeller-backed, CIA-inspired, corporate-governance socialist revolution model, to feedback on a bottom-up perverting of values through intense social engineering from family-to-school through social media's pervasive hold on kids. This marriage desires technocratic control of 8 billion souls. Or as 'The Prophet' Yuval Noah Harari calls them in Palestine: "guinea pigs."<sup>389</sup> Jane Goodall wants less of us<sup>390</sup> while destructing our economies and livelihoods down to subsistence levels.

A final resonance to 1933, after Hitler's 1924 incarceration, he picked up right where he left the failed 1923 Beer Hall Putsch. The collapse of world economies - the 1929-33 Great Depression - left a weak and rudderless

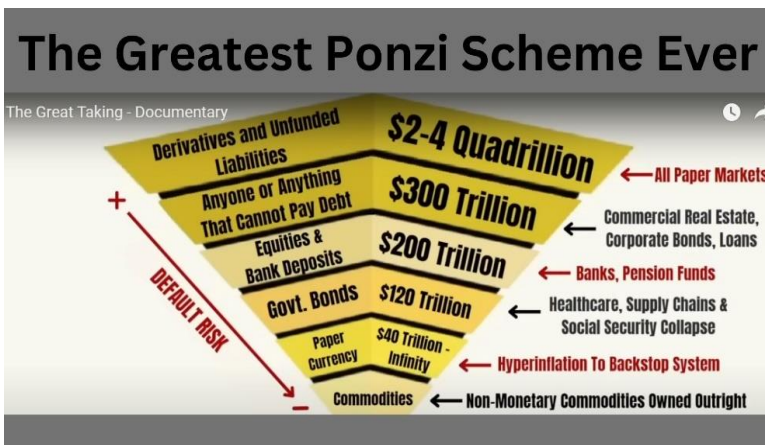
Germany primed and ready for social upheavals. Germany endured worse economically than in the United States by most statistical accounts, inviting extreme thinking. Deflation, bankruptcies, and beggar-thy-neighbor policies meant real *cults of personality* grew. Hitler was the most visible due to his immediate seizure of control in early 1933. (FDR was almost coup d'état out by a financial cabal including Prescott Bush.<sup>391</sup>)

(These “cults” are happening again. These are to create a left-right dichotomy - *to weaken both* - who might stand up against the GP’s establishment narratives and their desires in the 2030 Agenda. Many, however, will never reassess their mindset or framing of this argument.)



Prior representatives of these cults of personalities: Hitler, Mussolini, Stalin, and to a lesser degree, Tōjō, were all responsible for an Axis solidifying towards a totalitarian response that ultimately resulted in World War II (Stockwin, 27).<sup>392</sup> Western peoples had their obsessions with Churchill, FDR and Generals like MacArthur in capturing a lion’s share of praise, deservedly, or not. Men are not purely anything. Remember that.

Klaus’s birth in Germany happened as Adolf Hitler was named Time’s *Man of the Year* in 1938.<sup>393</sup> World War was but one year away.
